Dear Mr. Billings:

Please find attached is an open remediation site, 1RP-335, (according to NMOCD records) that was sold by ConocoPhillips (COP). Since this site no longer is under COP control. It is not possible to conduct inspections nor remediation activities. The site was initially included in the ACO records, but after further research we have identified this site as transferred to other operators. Furthermore, during a brief desktop review, it was observed the site has now grown ample vegetation across the affected site. The area seems to have been remediated already. An attempt was made to access the site physically but due to closed gate and no longer owning well or mineral rights; we are no longer able to access the site.

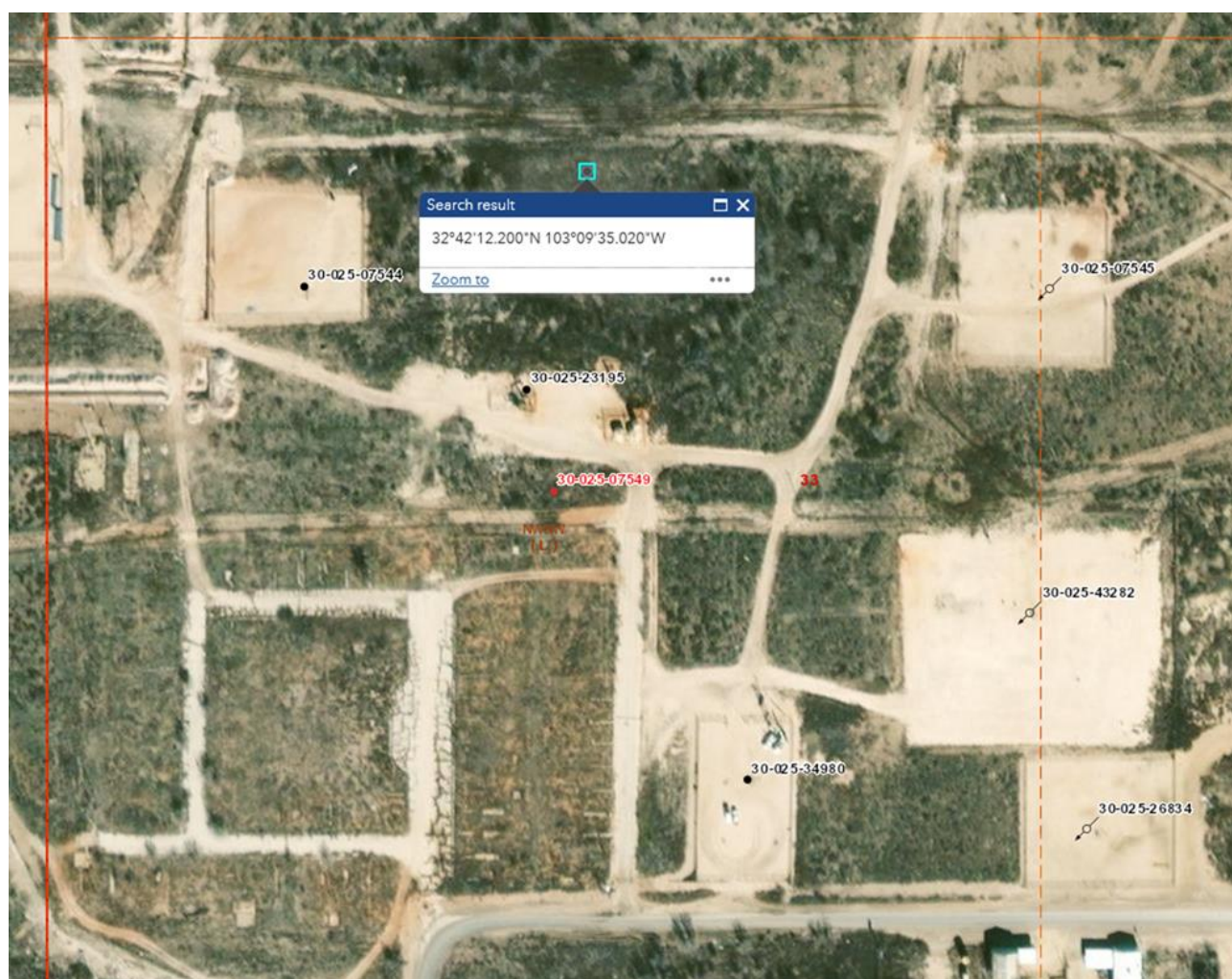
