You have requested this non-standard horizontal spacing unit in order to develop the acreage as a single communitized area and to efficiently locate surface facilities, reduce surface disturbance, promoting conservation within all of Section 29. Therefore, reducing waste while protecting correlative rights within the referenced Horizontal Spacing Unit.

Pursuant to the authority conferred by Division Rule 19.15.16.15(B)(5) NMAC, the above-described **non-standard horizontal spacing unit is hereby approved**. Further, the Applicant may add additional wells to the horizontal spacing unit. The additional well(s) shall be designated to the same horizontal spacing unit and pool/formation.
