Permian Resources Operating, LLC ("Permian") (OGRID No. 372165), pursuant to Division Rules 19.15.16.15(C)(6) and 19.15.15.13 NMAC and applicable rules governing acreage and well location requirements for the Bilbrey Basin; Bone Spring [5695], seeks administrative approval of an unorthodox well location for its **Gouda Fed Com #304H** well (API No. 30-025-PENDING), in a 319.66-acre, more or less, spacing unit underlying the E/2 E/2 of Section 32, Township 21 South, Range 25 East, and the E/2 E/2 of Section 5, Township 22 South, Range 32 East, Lea County, New Mexico.

The location for the Gouda Fed Com #304H oil well is as follows:

- Surface hole location: 797' FSL and 1,105' FEL (Unit P) of Section 5, T22S-R32E
- First take point: 100' FSL and 1,252' FEL (Unit P) of Section 5, T22S-R32E
- Last take point: 100' FNL and 1,252' FEL (Unit A) of Section 31, T21S-R32E
- <u>Bottom hole location:</u> 100' FNL and 1,252' FEL (Unit A) of Section 31, T21S-R32E

Since this acreage is governed by the Division's statewide rules, the completed interval for this well will be unorthodox because it is closer than the standard offsets to the western boundary of the spacing unit—thus, encroaching on the Mozzarella well spacing unit in the W/2 E/2 and E/2 W/2 of Section 32, T21S-R32E, and the W/2 E/2 and E/2 W/2 of Section 5, T22S-R32E, NMPM, Lea County, New Mexico. As explained in the engineering statement included as **Exhibit A**, approval of the unorthodox, completed interval is necessary to allow Permian to use its preferred well spacing plan for horizontal wells in this area, which is necessary to maximize recovery and prevent waste.

Exhibit B is a Form C-102 showing the Gouda Fed Com #304H well encroaches on the unit/tracts to the west.

Exhibit C is a plat for Section 32, T21S-R32E, and Section 5, T22S-R32E, that shows the Gouda Fed Com #304H well in relation to the adjoining spacing unit/tracts to the west. The designated operator of the offsetting unit is Permian, which also includes the following other working interest owners: Fasken Acquisitions 02, Ltd., Paladin Energy Corp., Raven Resources, LLC, Sunrise Oil and Gas Prop., LLC, ConocoPhillips Co., and Chevron USA, Inc. In addition, the exhibit identifies that this includes New Mexico State Land Office ("SLO") and Bureau of Land Management ("BLM") leases. Accordingly, the "affected persons" ¹ are Permian, the other working interest owners, SLO and the BLM.

Permian Resources Operating, LLC ("Permian") respectfully requests administrative approval on a non-standard location for the Gouda Federal Com #304H to allow the completed interval to be less than 330 feet from the western boundary of the existing offsetting 639.34-acre horizontal spacing unit. This well is located in the Bilbrey Basin, Bone Spring pool (5695). Due to the optimal spacing of the planned wells in this section, Permian has planned the Gouda Federal Com #304H, Gouda Federal Com #404H, Mozzarella Federal Com #302H and Mozzarella Federal Com #402H wells with at least 922 feet of spacing between each well. This spacing pattern causes the Gouda Federal Com #304H to be drilled less than 330 feet from the western boundary of the spacing unit. Permian requests approval of this non-standard location because it is necessary to avoid causing wasted resources and reducing the production of the wells listed above.




