I have picked up this review with the departure of Alana. She was able to get the additional information from Geolex to complete the application following the technical review. However, in my review for the final order preparation I note that an "open-hole" completion for this San Andres disposal well. OCD no longer approves open-hole completions except for Silurian-Devonian wells where the confining layer is a shale. Additionally, the open-holes approved under prior administrations for San Andres have resulted in waterflows in this formation which interferes in drilling/completions, fails to protect correlative rights especially in areas with waterflood operations (Hobbs outflow), and offers no downhole control should zone isolation be required. Therefore, if BC

& D Operating wishes to proceed with the approval of the disposal well, the OCD require the extension of the production casing to TD with perforations for injection. Please contact your client and, if they concur, provide an updated wellbore diagram with the change in construction. Please contact me with any questions. PRG




Figure 3. Proposed Javelina 26-25-37 #1 well schematic Released to Imaging: 8/22/2023 9:35:37 AM
