Pursuant to Division Rule 19.15.16.15(B)(5), Mewbourne Oil Company ("Mewbourne") respectfully requests administrative approval of a non-standard proration unit for its proposed JOHN DENVER 15/14 FED COM #521H, JOHN DENVER 15/14 FED COM #523H, JOHN DENVER 15/14 FED COM #526H . and JOHN DENVER 15/14 FED COM #528H wells listed above. These wells will be drilled as horizontal oil wells in the Sand Tank; Bone Spring (Oil) pool (96832).

The JOHN DENVER 15/14 FED COM #521H, JOHN DENVER 15/14 FED COM #523H, JOHN DENVER 15/14 FED COM #526H and JOHN DENVER 15/14 FED COM #528H wells will be dedicated to a 1280.00-acre proration unit comprising all of Section 14 and all of Section 15, T-18-S, R-29-E, Eddy County, New Mexico.
