WPX Energy Permian, LLC, ("WPX"), OGRID No. 246289, is seeking administrative approval of an unorthodox well location ("NSL") for the Horn 22-27-34 Fed Com 422H Well (the "422H Well") (API 30-015-49834) to be completed within the Purple Sage; Wolfcamp (Gas) Pool (Pool Code 98220) underlying Sections 22, 27 and 34, Township 26 South, Range 29 East, NMPM, Eddy County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well that will be drilled as follows:

- Surface Location (SL): 1068' from the South line and 1194' from the East line of Section 15, Township 26 South, Range 29 East;
- Bottom Hole Location (BHL): 1873' from the North line and 330' from the East line of Section 34, Township 26 South, Range 29 East;
- First Take Point (FTP): 100' from the North line and 530' from the East line of Section 22, Township 26 South, Range 29 East;
- Last Take Point (LTP): 1787' from the North line and 330' from the East line of Section 34, Township 26 South, Range 29 East.

WPX has included as Exhibit B a letter explaining why this application is needed. This well will produce from the Purple Sage Wolfcamp Pool (Pool Code 98220). There are special pool rules for this pool under Order No. R-14262, that establish 330' foot setback requirements

The unorthodox location will encroach towards (1) the E/2 S/2 of Section 15, Township 26 South, Range 29 East, NMPM, Eddy County, New Mexico to the north; and (2) the New Mexico/Texas State Line to the south. (WPX has found Mewbourne Oil Company and BPX Operating Company to be the affected parties to the south).




