ORDER OF THE COMMISSION

THIS MATTER comes before the New Mexico Oil Conservation Commission (“Commission”) on Northwind Midstream Partners LLC’s (“Northwind”) (OGRID No. 331501) and the Oil Conservation Division’s (the “Division”) Joint Motion to Remand C-108 for Administrative Review and Approval (the “Joint Motion”). The Commission conducted a status conference on November 8, 2023, and heard presentations from the Northwind and the Division on the Joint Motion on December 14, 2023. The Commission having heard the arguments authorized the Chair to approve a remand to the Division on the condition Northwind and the Division file a Joint Motion consistent with the presentations made on December 14, 2023. Consistent with that authorization and having considered the Joint Motion and the record in this case, and otherwise being fully advised in the premises, the Commission, through the Chair, hereby **GRANTS** the Motion and **ORDERS**, as follows.

Northwind Midstream Partners LLC’s updated Form C-108 for its proposed Salt Creek AGI #2 well, reflected in Exhibit B to the Motion, is hereby remanded to the Division for administrative review and approval, pursuant to the Division’s authority to enter administrative approvals under 19.15.26 NMAC.
