Novo Oil & Gas Northern Delaware, LLC ("Novo"), a wholly owned subsidiary of Permian Resources Operating, LLC ("Permian") (OGRID No. 372165), pursuant to Division Rules 19.15.16.15(B)(5) and 19.15.15.11 NMAC and applicable rules governing acreage and well location requirements for the Purple Sage; Wolfcamp pool (Code 98220), seeks administrative approval of Non-Standard Horizontal Spacing Unit for its Rana Salada 0604 Federal Com 203H & Rana Salada 0604 Federal Com 223H wells, in a 396.67-acre, more or less, spacing unit underlying the N/2 SW/4 of Section 4, N/2 S/2 of Section 5, and N/2 S/2 of Section 6, Township 23 South, Range 29 East, Eddy County, New Mexico.

Approval of the Non-Standard Horizontal Spacing Unit is necessary to allow Permian to co-develop the Rana Salada 0503 Federal Com, Rana Salada 0605 Federal Com, and Rana Salada 604 Federal Com horizontal spacing units together.¹ If standard Purple Sage Wolfcamp spacing is used, there would be three separate overlapping spacing units. This would cause ownership of the units to be split in a manner that is not representative of the actual development of the resource. Further, if standard spacing was applied, a portion of the XTO Big Eddy Unit (shown on Exhibit

B) would be covered by the Rana Salada 0503 Federal Com unit. Finally, the non-standard spacing has been agreed to by all working interest owners and is reflected in the Joint Operating Agreements for these units. If Permian is required to utilize standard spacing, the agreement would no longer be valid and forced pooling may be required. A Non-Standard Horizontal Spacing Unit permits Permian to use its preferred well spacing plan for horizontal wells in this area, which will maximize recovery, prevent waste, and protect correlative rights.

Exhibit A is a Form C-102 showing the location of the Rana Salada 0604 Federal Com 203H and Rana Salada 0604 Federal Com 223H wells, in a 396.67-acre, non-standard horizontal spacing unit.

Exhibit B is a plat for the N/2 SW/4 of Section 4, N/2 S/2 of Section 5, and N/2 S/2 of Section 6, Township 23 South, Range 29 East, in relation to the adjoining tracts. Exhibit B also identifies the operators of the adjoining tracts, as well as any wells operated by those offset operators.

Exhibit C is a spreadsheet listing all affected persons that were sent a copy of this application with all attachments by certified mail advising that any objections must be filed in writing with the Division within 20 days from the date the Division receives the application.
