The OCD was notified by New Mexico State Land Office "NMSLO", that it is protesting the following administrative applications of Pilot Water Solutions SWD LLC (Pilot Water Solutions) for produced water disposal in Lea County, NM:

1. Mariota SWD State #1, Located in 2004' FNL & 1096' FEL in Section 8 T19S R37E
2. Lamar SWD State #1, Located in 2596' FSL & 351' FEL in Section 3 T19S R37E
3. Staubach SWD State #1, Located in 470' FNL & 855' FEL in Section 10 T19S R37E
4. Bush SWD State #1, Located in 1492' FNL & 2092' FEL in Section 15 T19S R37E
5. Sanders SWD State #1, Located in 499' FSL & 1302' FEL in Section 15 T19S R37E

NMSLO is identified as an affected person for the referenced applications. For these applications to proceed, Pilot Water Solutions has two options; either resolve the matter with the protesting party or to go to a hearing before the Division. If the protest is withdrawn, then the applications could be processed administratively. Meanwhile, OCD will retain your applications until a resolution is reached on the status of the submittals. Million, Dean, and Phil:

This serves as a Pilot Water SWD Solutions, LLC, Lamar SWD State #1 NMSLO Notice of Protest.

Be advised that even if the OCD approves the Administrative SWD Application, the NMSLO shall not grant a Salt Water easement (No surface occupancy).

Restated, this is a waste of time for the Applicant and the OCD to proceed.

The proposed injection interval of the Lamar SWD State #1 is within the injection interval of the State AB SWD #1, API 30-025-23786

State AB SWD #1 has injected over 9.4 million barrels of produced water

The Lamar SWD State #1 is approximately 3600 feet Southeast of the State AB SWD #1

Lastly, the ½ mile buffer of the State AB SWD #1 overlies a portion of the Lamar SWD State #1.
