Dear Mr. Lowe,

Matador Production Company respectfully requests administrative approval of a non-standard location for its Teri 22-17S-37E State #1 (API No. 30-025-49654), to be completed in the Humble City; Wolfcamp (Pool Code 33510).

Matador's Teri 22-17S-37E State #1 (API No. 30-025-49654) is a directional well, which Matador previously drilled and completed in the Strawn formation in the Humble City; Strawn, Southwest (Pool Code 96558). Matador previously received an approved non-standard location for that Strawn completion under NMOCD Administrative Order No. NSL-8278.

Based on the results from the Strawn completion, Matador plans to potentially test another zone in the existing wellbore in the Wolfcamp formation. Matador will be separately filing a sundry for approval of that operation and plugging back the Strawn formation, but files this application for a non-standard location with respect to such Wolfcamp completion. In addition, Matador may also plan to test the Third Bone Spring formation in this well, for which Matador will file a separate application for non-standard location for that formation.

Matador's Wolfcamp well will be completed only at the bottom hole location. Matador is not aware of any special pool rules for the Humble City; Wolfcamp (Pool Code 33510), and therefore pursuant to NMAC 19.15.15.9 the spacing in this oil pool will be 40-acre spacing with the well to be no closer than 330' to a boundary unit.

As set forth below, Matador's application requests a non-standard location because the proposed bottom hole is closer than 330' to the boundary of the 40-acre spacing unit. The details of Matador's proposed recompletion in the Wolfcamp formation is as follows:

1. Well name: Teri 22-17S-37E State #1 (API No. 30-025-49654)
2. Pool: Humble City; Wolfcamp (Pool Code 33510)
3. Spacing Unit: N/E NE/4 of Section 22, Township 17 South, Range 37 East, NMPM, Lea County, New Mexico.

This is a standard spacing unit in this pool pursuant to NMAC 19.15.15.9. A copy of a draft form C102 for the well is enclosed. The well will be the first well completed in this spacing unit in this pool.

4. Acreage in Spacing Unit: 40 acres.
5. Directional Well Location:
 - a. Directional Well Surface Location: 100' FNL, 1,130' FEL of Section 22, T17S, R37E, Lea County, New Mexico.
 - b. Directional Well Bottom Hole Location: 51' FNL, 1,344' FEL of Section 22, T17S, R37E, Lea County, New Mexico.
 - c. Directional Well's Completed Interval: The well's entire completed interval will be located at the bottom hole location; specifically, 51' FNL, 1,344' FEL of Section 22, T17S, R37E, Lea County, New Mexico.
6. Matador requests this non-standard location because the wellbore has already been drilled when Matador previously drilled and completed this well in the deeper Strawn formation. The Wolfcamp target that Matador intends to test is located in the existing wellbore at the bottom hole location listed above, and Matador has no way of changing that bottom hole to a standard location without re-drilling the entire well. Matador does not believe it would be cost-efficient to re-drill the entire well to test the Wolfcamp at a standard location and it may be cost-prohibitive. Accordingly, the granting of Matador's application would prevent waste and lead to the most efficient development of this acreage.
7. The well is in an oil pool and we anticipate the well will produce both oil and gas.

8. Pursuant to NMAC 19.15.4.12, the affected persons in this circumstance are those located in the adjoining quarter-quarter sections. Accordingly, the areas of encroachment are (i) the NW/4 NE/4 of Section 22, T17S, R37E, Lea County, New Mexico, and (ii) the S/2 SE/4 of Section 15, T17S, R37E, Lea County, New Mexico.

The NW/4 NE/4 of Section 22, T17S, R37E, Lea County, New Mexico is one State tract in which Greyhound Resources, LLC owns 100% of the working interest. A waiver of objection to this application from Greyhound Resources, LLC is being submitted herewith.

The S/2 SE/4 of Section 15, T17S, R37E, Lea County, New Mexico is one fee tract in which there are multiple undivided interest owners, each of whom is set forth on the notice list attached hereto. Matador will provide notice of this application to each of these persons, as shown on the enclosed exhibit.

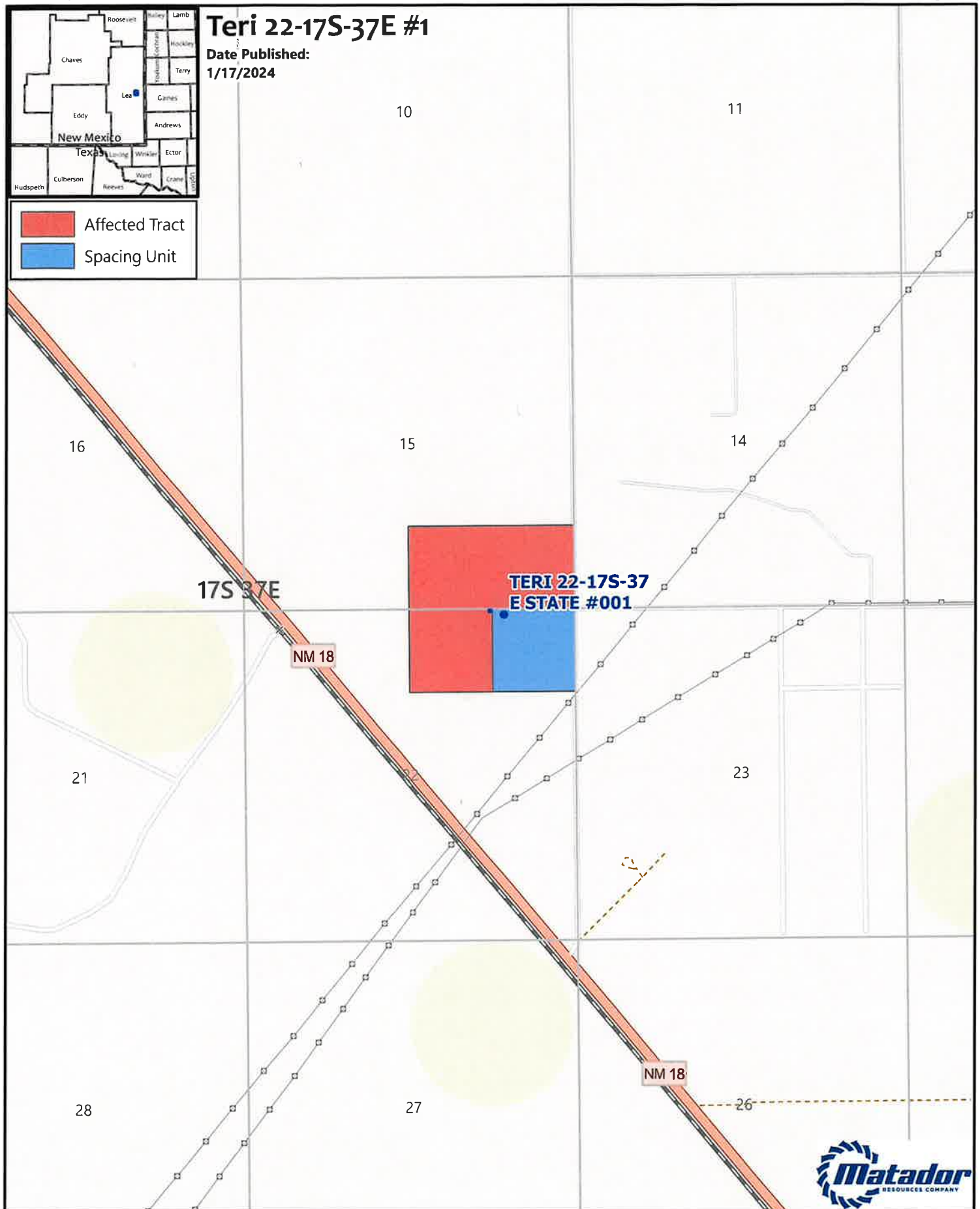
