Pursuant to Division Rule 19.15.15.13, Mewbourne Oil Company ("Mewbourne") respectfully requests administrative approval of an unorthodox gas well location for the above captioned well. This well will be drilled as a horizontal gas well in the Purple Sage Wolfcamp (Gas) Pool (98220).

The above well will be dedicated to a standard 640-acre gas spacing unit comprising the S/2 of Sec. 17 and the SE/4, Lots 9, 10, 11, 12 of Sec. 18, T22S, R28E, Eddy County, New Mexico, containing 621.13 Acres, more or less.

The Purple Sage Wolfcamp (Gas) Pool is currently governed by Special Pool Rules, Hearing Order No. R-14262 which requires standard 320-acre gas spacing and proration units with wells to be located no closer than 330 feet to the outer boundary of the spacing unit, nor closer than 10 feet to any interior quarter-quarter section line or subdivision inner boundary, or in the case of a horizontal well, no closer than 330 feet to the outer boundary of the producing area.

Attached is a Form C-102 for the well depicting the surface, first take point, and bottomhole locations for the above captioned wells. Also attached is a map showing the affected offset acreage, a horizontal well plan, and notice list.




