Devon Energy Production Company, LP., (“Devon”), OGRID No. 6137, is seeking administrative approval of an unorthodox well location (“NSL”) for the Van Doo Dah 33-28 Fed Com 830H Well (the “830H Well”) (API No. 30-025-Pending) to be completed within the WC-025 S253227A;LWR Wolfcamp (Gas) Pool (Pool Code 98203) underlying the E/2 of Sections 33 and 28, all in Township 25 South, Range 32 East, NMPM, Lea County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well that will be drilled as follows:

- Surface Location (SL): 180’ from the South line and 2326’ from the East line (Unit O) of Section 33, Township 25 South, Range 32 East;
- Bottom Hole Location (BHL): 20’ from the North line and 1980’ from the East line (Unit B) of Section 28, Township 25 South, Range 32 East;
- First Take Point (FTP): 100’ from the South line and 1980’ from the East line (Unit O) of Section 33, Township 25 South, Range 32 East;
- Last Take Point (LTP): 100’ from the North line and 1980’ from the East line (Unit B) of Section 28, Township 25 South, Range 32 East.

Devon has included as Exhibit B, a letter explaining why this application is needed. This well will produce from the WC-025 S253227A;LWR Wolfcamp Gas Pool (Pool Code 98203).

The unorthodox location will encroach towards the (1) SE/4 of Section 21, Township 25 South, Range 32 East, NMPM, Lea County, New Mexico; and in the (2) NE/4 of Section 4, Township 26 South, Range 32 East, NMPM, Lea County, New Mexico.

Devon attests that, on or before submission of this application, it provided notice to the affected persons (1) in the SE/4 of Section 21, Township 25 South, Range 32 East and (2) in the NE/4 of Section 4, Township 26 South, Range 32 East, NMPM, Lea County, New Mexico; said notice as described satisfies all provisions of 19.15.4.12A(2) NMAC; copies of the application and required plat maps were furnished. 

Devon Energy Production Company, L.P. respectfully requests administrative approval of a non-standard location for the Well referenced above. The Well is in the Lower Wolfcamp Gas Pool (Pool Code 98203). It is Devon's responsibility as a prudent operator to minimize reserves left in the ground. Decreasing the first and last take point from three hundred and thirty feet (330') to one hundred feet (100') will increase the wells effective lateral length by 460 feet thereby increasing ultimate recovery of reserves and thereby preventing waste of natural resources.


