Devon Energy Production Company, LP., (“Devon”), OGRID No. 6137, is seeking administrative approval of an unorthodox well location (“NSL”) for the Van Doo Dah 33-28 Fed Com 833H Well (the “833H Well”) (API No. 30-025-Pending) to be completed within the WC-025 S253227A;LWR Wolfcamp (Gas) Pool (Pool Code 98203) underlying the W/2 of Sections 33 and 28, all in Township 25 South, Range 32 East, NMPM, Lea County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well that will be drilled as follows:

- Surface Location (SL): 180’ from the South line and 2356’ from the East line (Unit O) of Section 33, Township 25 South, Range 32 East;
- Bottom Hole Location (BHL): 20’ from the North line and 2420’ from the West line (Unit C) of Section 28, Township 25 South, Range 32 East;
- First Take Point (FTP): 100’ from the South line and 2420’ from the West line (Unit N) of Section 33, Township 25 South, Range 32 East;
- Last Take Point (LTP): 100’ from the North line and 2420’ from the West line (Unit C) of Section 28, Township 25 South, Range 32 East.

Devon has included as Exhibit B, a letter explaining why this application is needed. This well will produce from the WC-025 S253227A;LWR Wolfcamp Gas Pool (Pool Code 98203).

The unorthodox location will encroach towards (1) the S/2 of Section 21 (encroaches toward the SW/4 and SE/4 of Section 21 based on a 330' radial analysis of the LTP location); (2) the E/2 of Sections 33 and 28, all in Township 25 South, Range 32 East; and (3) the N/2 of Section 4, Township 26 South, Range 32 East (encroaches toward the NW/4 and NE/4 of Section 4 based on 330' radial analysis of the FTP location).

Devon attests that, on or before submission of this application, it provided notice to the affected persons (1) in the S/2 of Section 21; (2) the E/2 of Sections 33 and 28, all in Township 25 South, Range 32 East; and (3) in the N/2 of Section 4, Township 26 South, Range 32 East, NMPM, Lea County, New Mexico; said notice as described satisfies all provisions of 19.15.4.12A(2) NMAC; copies of the application and required plat maps were furnished. Devon also provided notice to the Bureau of Land Management to the extent that federal leases are involved pursuant to 19.15.2.7A(8)(d) NMAC. Devon provides herein a sectional map of this area, attached as Exhibit C. Proof of mailing, along with a copy of the notice letter sent to listed affected persons and parties, is attached hereto as Exhibit D. Devon has indicated that there is no pooling case associated with this application.



Dear Mr. Lowe:

Devon Energy Production Company, L.P. respectfully requests administrative approval of a non-standard location for the Well referenced above. The Well is in the Lower Wolfcamp Gas Pool (Pool Code 98203). It is Devon's responsibility as a prudent operator to minimize reserves left in the ground. In order to decrease the between well spacing thereby maximizing ultimate recovery of reserves and preventing waste of natural resources, Devon desires to drill the Van Doo Dah 33-28 833H well less than 330' from the eastern boundary of an E/2 horizontal spacing unit AND by decreasing the first and last take points three hundred and thirty feet (330') to one hundred feet (100') will increase the wells effective lateral length by 460 feet thereby increasing ultimate recovery of reserves and thereby preventing waste of natural resources.


