Mewbourne Oil Company supports the application of Solaris Water Midstream, LLC to secure a salt water disposal (SWD) permit for the proposed Klein 4 SWD #1, located in Lea County, New Mexico. The original permit was submitted to the Division in December 2018 and an amended application, to account solely for the approximate 400' surface location move, was submitted in April 2019. The proposed well is located on Mewbourne leasehold and we have worked with Solaris to find a mutually acceptable surface location for the SWD.

Mewbourne has additional development drilling planned in this area and asks the Oil Conservation Division to consider prioritizing the approval of the Klein 4 SWD application, since there is a true need for this additional disposal capacity in this developing area.
