Good afternoon, Ms. Huntington. Enduring's request has been received in a timely fashion and will maintain the UIC permit's authority to inject. Beside submitting the initial written notice, OCD will require two additional information requirements in order to approve an Extension of Time (EOT). Please submit a letter addressed to the Director through the OCD Engineering e-mail that includes the following information on corporate letterhead:

1. Pertinent well info: Well name, API number, location, SWD order no., approved interval, order date, etc.
2. The information which provided in the e-mail (the need for the extension and the length of the extension (one-year/six months)).
3. *A statement that there have been no changes (or there have been changes) in "affected persons" notified during the original application. [If a new "affected person" is discovered, then a new notice with application will be sent to them].*
4. *A statement regarding AOR wells: if they have not changed or if there are new wells, the information on the new AOR wells.*

This document can be provided based on the results of the two information requests (such as additional notice may require the more time to notice any new affected person). Please contact if you have any questions. PRG
