Kristen Houston:

The Oil Conservation Division (“OCD”) has reviewed the May 1, 2024, request to extend the deadline in the referenced order to re-establish injection into referenced well. The request, which was received prior to the deadline for the well to lose its injection authority on June 25th 2024 due to the well has been inactive for the last 12 consecutive months, states the reasons for granting an extension, that no additional wells penetrating the approved injection interval have been drilled within the Area of Review since the referenced order was granted, and that additional affected parties in the AOR, if any, were notified of your extension request and did not protest the extension. Accordingly, OCD reviews your request administratively.

The OCD finds that for reasons you have stated, the granting of this request to extend the deadline is in the interest of conservation, will prevent waste, and will protect the environment. Therefore, the deadline to recommence injection for the existing order is hereby extended until **June 25th, 2025**.

All requirements of the above referenced Administrative Order and agreements in the application remain in full force and effect. Any further extension of the deadline to recommence injection shall be considered but must be submitted in writing prior to the new extended deadline.
