Pursuant to Division Rule 19.15.16.15(B)(5), Mewbourne Oil Company ("Mewbourne") respectfully requests administrative approval of a non-standard proration unit for its proposed Dire Wolf 16-9 FED COM #521H, Dire Wolf 16-9 FED COM #523H, Dire Wolf 16-9 FED COM #526H, Dire Wolf 16-9 FED COM #528H wells listed above. These wells will be drilled as horizontal oil wells in the Corbin; Bone Spring pool (13160).

The Dire Wolf 16-9 FED COM #521H, Dire Wolf 16-9 FED COM #523H, Dire Wolf 16-9 FED COM #526H, Dire Wolf 16-9 FED COM #528H wells will be dedicated to a 1280.00-acre proration unit comprising all of Section 9 and all of Section 16, T-18-S, R-33-E, Lea County, New Mexico. There are currently no other existing Bone Spring Oil wells producing from within the proposed spacing unit.

The affected offset acreage comprises all of Sections 3, 4, 5, 8, 10, 15, 17, 20, 21 and 22 all located in T18S-R33E (See attached map). Consequently, notice of this application is being provided to all parties listed on the attached list of affected parties.

Mewbourne is seeking approval of this NSP to eliminate the need for separate production facilities and additional administrative approvals in addition to giving us flexibility in locating our laterals and drilling infills in other horizons. These reasons will provide for reducing waste and our surface imprint while protecting correlative rights within the referenced horizontal spacing unit. This NSP will also possibly reduce emissions by consolidating the tank battery.

Mewbourne applied for federal permits to drill these wells back in August of 2022. The permits are still pending approval by the New Mexico Bureau of Land Management, and we expect them to be approved soon. We still respectfully request the NMOCD to still approve this NSP even though we don't yet have API numbers issued to us since the APDs are still pending approval from the BLM.

Notice by certified mail, return receipt requested, has been given to the affected parties listed in the notification list attached.
