You have requested to drill this horizontal well at an unorthodox well location described above in the referenced pool or formation. 19.15.16.15(B)(3)(a) NMAC governs this proposed well and provides that the operator shall dedicate to each horizontal **gas** well a standard horizontal spacing unit that comprises of one or more contiguous tracts that the horizontal well’s completed interval penetrates, each of which consists of a governmental quarter section or equivalent. 19.15.16.15(C)(1)(a) NMAC governs the distance in the horizontal plane from any point in the completed interval to any outer boundary of the horizontal spacing unit, measured along a line perpendicular to the completed interval or to the tangent thereof, shall be a minimum of 660 feet for a **gas** well. 19.15.16.15(C)(1)(b) NMAC governs the first and last take point of a horizontal

well shall be no closer than 330 feet for a **gas** in the horizontal plane, to any outer boundary of the horizontal spacing unit.

The request to deviate from an orthodox location has met all requirements of 19.15.16.15 (C)(5)(a) NMAC. It is understood that you are seeking this exception in order to create a non-standard location, comprised of First and/or Last Take Points referenced above within the described Horizontal Spacing Unit.

This well's completed interval is as close as 95 feet to the western edge, 61 feet to the eastern edge, and 440 feet to the southern edge of the proposed horizontal spacing unit. Encroachment will impact the following tract(s).

- Section 09, encroachment to the NW/4 & SE/4
- Section 10, encroachment to the S/2
- Section 11, encroachment to the SW/4 & NE/4

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in Paragraph (8) Subsection A of 19.15.2.7 NMAC, in all adjoining units towards which the proposed location encroaches.

Division understands you are seeking this unorthodox location to avoid causing wasted resources and reducing production from current and future development within the Wolfcamp formation underlying NE/4 of Section 09, N/2 of Section 10 and the NW/4 of Section 11. Thereby preventing waste within the formation all while protecting the correlative rights of affected persons in the encroached tracts.

Your application has been filed under 19.15.16.15(C)(6) NMAC, 19.15.15.13 NMAC and 19.15.4.12 (A)(2) NMAC.

Per Subsection B of 19.15.15.13 NMAC, **Division approves this unorthodox location.**

Reference this NSL order number on the As Drilled C-102 submitted with the Authorization to Transport, to place this well into production.

Devon Energy Production Company, L.P. (“Devon”) (OGRID No. 6137), pursuant to Division Rules 19.15.16.15.C(6) and 19.15.15.13 NMAC and applicable rules governing acreage and well location requirements for the Alacran Hills; Wolfcamp Gas Pool [70070], seeks administrative approval of an unorthodox well location for its Bent Tree 9-11 Fed Com #622H well (API No. 30-015-49031), in an 640-acre, more or less, spacing unit underlying the NE/4 of Section 9, N/2 of Section 10 and the NW/4 of Section 11, Township 21 South, Range 27 East, Eddy County, New Mexico.

The location for the proposed **Bent Tree 9-11 Fed Com #622H well** is as follows:

- Surface location: 1,869’ FNL and 2,513’ FWL (Unit F) of Section 9
- First take point: 2,200’ FNL and 2,545’ FEL (Unit G) of Section 9
- Last take point: 2,200’ FNL and 2,579’ FWL (Unit F) of Section 11
- Bottom location: 2,200’ FNL and 2,659’ FWL (Unit F) of Section 11

Since this acreage is governed by the Division’s statewide rules, the proposed first and last take points for this well will be unorthodox because they are closer than the standard offsets to the eastern and western boundaries of the spacing unit—thus, encroaching on Mewbourne Oil Company’s Cholula spacing unit to the east and their Screaming Eagle spacing units to the west. Additionally, Devon has planned their Bent Tree Upper Wolfcamp development with a spacing

pattern that causes the Bent Tree 9-11 Fed Com #622H well to be drilled less than 660 feet from the southern boundary—thus, encroaching on Devon’s Bent Tree 9-11 spacing unit to the south.

Exhibit A is an Engineering Statement explaining why approval of the application is necessary.

Exhibit B is a Form C-102 showing the **Bent Tree 9-11 Fed Com #622H** well encroaches on the units to the east in the NE/4 of Section 11 and N/2 of Section 12, T21S-R27E (Mewbourne’s Cholula HSU), as well as to the west in Lots 1-2, E/2 NW/4, and NE/4 (N/2 equivalent) of irregular Section 7, N/2 of Section 8, and NW/4 of Section 9, T21S-R27E (Mewbourne’s Screaming Eagles HSUs), and to the south in the S/2 of Sections 9 and 10 and the SW/4 of Section 11, T21S-R27E (Devon’s Bent Tree 9-11 HSU).

Exhibit C is a plat for the subject area, that shows the proposed Bent Tree 9-11 Fed Com #622H well in relation to the adjoining units to the east, west, and south. Exhibit B also includes an ownership list for the affected units to the east, west, and south, showing that the spacing units to the east and west are both operated by Mewbourne Oil Co. (“Mewbourne”). Devon is the operator of the Bent Tree 9-11 spacing unit to the south; the other interest owners in the unit are identified in the table below. In addition, the exhibit identifies that the offsetting units include state and federal leases. Accordingly, the “affected persons”¹ are Mewbourne, the other working interest owners in Devon’s Bent Tree 9-11 spacing unit, the New Mexico State Land Office (“SLO”), and the Bureau of Land Management (“BLM”).

Exhibit D is a spreadsheet listing all affected persons Devon provided notice and includes tracking information demonstrating that each of the affected persons was sent a copy of this application with all attachments by certified mail advising that any objections must be filed in writing with the Division within 20 days from the date the Division receives the application. The following are the affected persons:

Devon Energy Production Company, LP (“Devon”) respectfully requests administrative approval of non-standard location for the Bent Tree 9-11 Fed Com 622H well referenced above. The well is in the Alacran Hills; Wolfcamp (Gas) Pool (Pool Code 70070). Devon has planned their Bent Tree Upper Wolfcamp development with at least 440 feet of spacing between each well to efficiently drain this development area. This spacing pattern causes the 622H well to be drilled less than 660 feet from the southern boundary. Additionally, Devon proposes to decrease the first and last tank points from 330 feet to less than 100 feet, which will increase the completed horizontal lateral and the ultimate recovery of reserves. Therefore, approval of this non-standard location is necessary to avoid causing wasted resources and reducing production from current and future well development in the area.






