You have requested to complete this horizontal well as a **gas** well described above in the referenced pool or formation. This well is governed by special rules R-14262, for the Purple Sage; Wolfcamp (Gas) Pool and governs wells to be located at least 330 feet from the unit outer boundary of a spacing unit and no closer than 10 feet to any quarter – quarter section line. The completed intervals of horizontal wells are to be located no closer than 330 feet to the exterior boundary of a standard 320 - acre **gas** spacing unit.

The request to deviate from an orthodox location has met all requirements of 19.15.16.15 (C)(5)(a) NMAC. It is understood that you are seeking this exception in order to create a non-standard location, comprised of First and Last Take Points referenced above within the described Horizontal Spacing Unit.

The well's completed interval is as close as 100 feet to the northern and 50 feet to the western boundary of the horizontal spacing unit. Encroachment will impact the following tract(s).

Section 23, encroachment to the SE/4
Section 26, encroachment to the W/2
Section 35, encroachment to the W/2

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in Paragraph (8) Subsection A of 19.15.2.7 NMAC, in all adjoining units towards which the proposed location encroaches.

The Division understands you are seeking this unorthodox location to allow optimal well spacing within the Wolfcamp formation underlying the E/2 of Section 26 and the E/2 of Section 35, thereby increasing ultimate recovery of reserves and preventing waste of natural resources.

Your application has been filed under 19.15.16.15(C)(6) NMAC, 19.15.15.13 NMAC and 19.15.4.12 (A)(2) NMAC.

Per Subsection B of 19.15.15.13 NMAC, **Division approves this unorthodox location.**



WPX Energy Permian, LLC (“WPX”), OGRID No. 246289, is seeking administrative approval of an unorthodox well location (“NSL”) for the Steel Guitar 35-26 Fed Com 410H Well (the “410H Well”) (API No. 30-015-55940) to be completed within the Purple Sage; Wolfcamp (Gas) Pool (Pool Code 98220) underlying a standard 430.41-acre, more or less, horizontal spacing unit comprised of the E/2 of Sections 26 and 35, Township 26 South, Range 29 East, NMPM, Eddy County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well that will be drilled as follows:

- Surface Location (SL): 455’ from the North line and 1120’ from the East line (Unit A) of Section 26, Township 26 South, Range 29 East;
- Bottom Hole Location (BHL): 1788’ from the North line and 2590’ from the East line (Lot 10) of Section 35, Township 26 South, Range 29 East;
- First Take Point (FTP): 100’ from the North line and 2590’ from the East line (Unit B) of Section 26, Township 26 South, Range 29 East;
- Last Take Point (LTP): 1738’ from the North line and 2590’ from the East line (Lot 11) of Section 35, Township 26 South, Range 29 East.

WPX has included as Exhibit B, a letter explaining why this application is needed. This well will produce from the Purple Sage Wolfcamp Pool (Pool Code 98220). The special Division rules for the Purple Sage; Wolfcamp Pool establish 330' foot setback requirements which are laid out in Order No. R-14262. The completed interval and the first and last take points for the proposed well are closer than 330' from the boundary of the spacing unit.

The unorthodox location will encroach towards the S/2 of Section 23, the W/2 of Sections 26 and 35, and toward the Southern state line of New Mexico, all in Township 26 South, Range 29 East, NMPM, Eddy County New Mexico.

WPX attests that, on or before submission of this application, it sent notice to the affected persons in (1) the adjoining horizontal spacing unit which covers the SE/4 of Section 14 and the E/2 of Section 23, (2) the adjoining horizontal spacing unit which covers the SW/4 of Section 14 and the W/2 of Section 23, and (3) the adjoining horizontal spacing unit which covers the W/2 of Sections 26 and 35, all in Township 26 South, Range 29 East; said notice as described satisfies all provisions of 19.15.4.12A(2) NMAC; copies of the application and required plat maps were furnished. WPX has also provided notice to the Bureau of Land Management to the extent that federal leases are involved, pursuant to 19.15.2.7A(8)(d) NMAC. WPX provides herein a sectional map of this area, attached as Exhibit C. Proof of mailing, along with a copy of the notice letter sent to listed affected persons and parties, is attached hereto as Exhibit D. The pooling case associated with this application is Case No. 25058, Order No. R-23662.



WPX Energy Permian, LLC, a wholly owned subsidiary of Devon Energy Corporation, respectfully requests administrative approval of a nonstandard location for the Steel Guitar 26-35 Fed Com Well referenced above. This well is in the Purple Sage-Wolfcamp Gas Pool (Pool Code 98220). It is WPX's responsibility as a prudent operator to minimize reserves left in the ground. Decreasing the first and last take point from three hundred and thirty feet (330') to one hundred feet (100') will increase the wells effective lateral length by 460 feet thereby increasing ultimate recovery of reserves and thereby preventing waste of natural resources. Decreasing the setback for the completed interval to less than three hundred and thirty feet (330') will allow for more optimal well spacing within the unit, thereby increasing ultimate recovery of reserves and preventing waste of natural resources.






Steel Guitar 26-35 Fed Com 410H – NSL Offset Tract Map
