You have requested to drill this horizontal well at an unorthodox well location described above in the referenced pool or formation. 19.15.16.15(B)(1)(a) NMAC governs this proposed well and provides that the operator shall dedicate to each horizontal **oil** well a standard horizontal spacing unit that comprises of one or more contiguous tracts that the horizontal well's completed interval penetrates, each of which consists of a governmental quarter - quarter section or equivalent. 19.15.16.15(C)(1)(a) NMAC governs the distance in the horizontal plane from any point in the completed interval to any outer boundary of the horizontal spacing unit, measured along a line perpendicular to the completed interval or to the tangent thereof, shall be a minimum of 330 feet for an **oil** well. 19.15.16.15(C)(1)(b) NMAC governs the first and last take point of a horizontal

The request to deviate from an orthodox location has met all requirements of 19.15.16.15 (C)(5)(a) NMAC. It is understood that you are seeking this exception in order to create a non-standard location, comprised of Take Points referenced above, within the described Horizontal Spacing Unit.

This well's completed interval is as close as 110 feet to the western edge of the horizontal spacing unit. Encroachment will impact the following tracts.

Section 03, encroachment to the W/2 W/2 Section 10, encroachment to the W/2 W/2

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in 19.15.2.7(A)(8) NMAC, in all adjoining units towards which the proposed location encroaches.

The Division understands you are seeking this unorthodox location in order to allow for optimal well spacing, to avoid wasting resources, and reducing the production of the well within the unit. All while protecting the correlative rights within the Bone Spring formation underlying the E/2 W/2 of Section 03 and the E/2 W/2 of Section 10.

The completed interval of the well will be unorthodox because it is located less than 330' from the eastern boundary line of the offset tract. As explained in the engineering statement, included as **Exhibit A**, approval of the unorthodox, completed interval is necessary to allow Permian Resources to ensure optimal spacing of the wells, and improve overall productivity of the wells, which will prevent waste and protect correlative rights.

Permian Resources Operating, LLC ("Permian") respectfully requests administrative approval on a non-standard location for the Riddler Fed Com 122H to allow the completed interval to be less than 330 feet from the eastern boundary of the existing 320-acre horizontal spacing unit. This well is located in the [50461] Quail Ridge; Bone Spring, South. Due to the optimal spacing of the planned wells in this section, Permian has planned the Riddler Fed Com 401H, Riddler Fed Com 402H, Riddler Fed Com 111H, Riddler Fed Com 121H, and Riddler Fed Com 123H wells with at least 880 feet of spacing between each well. This spacing pattern causes the Riddler Fed Com 122H to be drilled less than 330 feet from the eastern boundary of the spacing unit. 


