In accordance with Division Rules 19.15.16.15(C)(6) and 19.15.15.13 NMAC BTA Oil Producers, LLC ("BTA") (OGRID No. 260297) seeks administrative approval of an unorthodox well location for its Bobwhite 22304 4-3 Fed Com 2H well, in a 640-acre, more or less, standard horizontal spacing unit underlying the S/2 of Sections 3 and 4, Township 23 South, Range 34 East, Lea County, New Mexico.

The as-drilled location for the **Bobwhite 22304 4-3 Fed Com** well ("Well"), is as follows:

- Surface Hole Location: 1,430' FSL and 400' FWL (Unit L) of Section 4
- First Take Point: 1,248' FSL and 343' FWL (Unit M) of Section 4
- Last Take Point: 1,284' FSL and 80' FEL (Unit P) of Section 3
- Bottom Hole Location: 1,283' FSL and 38' FEL (Unit P) of Section 3

The completed interval of the Well will be located less than 100 feet from the eastern boundary of the horizontal spacing unit. As explained in the engineering statement included as **Exhibit A**, approval of the unorthodox, BTA inadvertently completed the well 80' FEL while drilling. The request for a non-standard location of the completed interval is necessary to allow

BTA to produce the resources in the unit. The approval of an unorthodox well location will prevent waste and protect correlative rights.

**Exhibit B** is a Form C-102 for the Bobwhite 22304 4-3 Fed Com well. The well encroaches on the tracts to the east in the W/2 SW/4 of Section 2, Township 23 South, Range 34 East, Lea County.

**Exhibit C** is a plat for Sections 2, 3 and 4 of Township 23 South, Range 34 East, Lea County, New Mexico. The plat shows the Well in relation to the adjoining tracts/proposed spacing units. BTA is the designated operator of the adjoining spacing unit.

BTA Oil Producers, LLC ("BTA") respectfully requests administrative approval of a non-standard location for the Bobwhite 22304 4-3 Fed Com #2H well to allow the completed interval to be less than 100 feet from the eastern boundary of the existing 640.00-acre horizontal spacing unit.

BTA inadvertently completed the well 80' FEL. This variance from the planned 100' FEL LTP will not affect the wellbore's ability to maximize undeveloped resources, to reduce stranded resources and to maintain overall predicted recovery from the unit. The request for a non-standard location is therefore in the best interests of the mineral owners as well as the operator.
