Devon Energy Production Company, L.P. ("Devon"), OGRID No. 6137, is seeking administrative approval of an unorthodox well location ("NSL") for the War Club 2-3 Fed Com 823H Well (the "823H Well") (API No. Pending) to be completed within the Purple Sage; Wolfcamp (Gas) Pool (Pool Code 98220) underlying a standard 480-acre, more or less, horizontal spacing unit comprised of the S/2 of Section 3 and the SW/4 of Section 2, all in Township 22 South, Range 27 East, NMPM, Eddy County, New Mexico. 


