You have requested an exception pursuant to Rule 19.15.16.15(A)(3) NMAC, to approve a non-standard horizontal spacing unit consisting of the entire area described above as the horizontal

spacing unit. The proposed horizontal spacing unit does not consist of a quarter - quarter section or equivalent in both sections, as required by Rule 19.15.16.15(B)(1) NMAC.

We understand that you are seeking this exception for an allowance to create a non-standard horizontal spacing unit, comprised of the Proposed Horizontal Spacing Unit referenced above within Eddy County, New Mexico.

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in Paragraph (8) Subsection A of 19.15.2.7 NMAC, in all adjoining units which are to be being included.

You have requested this non-standard horizontal spacing unit to eliminate the need for separate production facilities and additional administrative approvals all while protecting the correlative rights within the Bone Spring formation. Thus, preventing waste and limiting the environmental footprint underlying N/2 Section 06 and the N/2 Section 05 within the referenced Horizontal Spacing Unit.

Pursuant to the authority conferred by Division Rule 19.15.16.15(B)(5) NMAC, the above-described **non-standard horizontal spacing unit is hereby approved**. Further, the Applicant may add additional wells to the non-standard spacing unit, the well(s) must be in the same horizontal spacing unit and pool/formation. The new well's APD shall reference this NSP order number on Form C-102 with an adjacent letter stating this request.

Pursuant to Division Rule 19.15.16.15(B)(5), Mewbourne Oil Company ("Mewbourne") respectfully requests administrative approval of a non-standard proration unit for its proposed Fresh Squeezed 6/5 wells listed above. These wells will be drilled as horizontal oil wells in the Shugart; Bone Spring, North Pool (56405). The current spacing units are 160 acre units, made up of 40 acre building blocks for the pool rules. Mewbourne is seeking an expanded 627.32 acre unit.

The Fresh Squeezed 6/5 Fed Com #521H, #523H, & #404H will be dedicated to a 627.32-acre gas spacing and proration unit comprising the North Half (N/2) of Sections 6 & 5, T-18-S, R-31-E, Eddy County, New Mexico. There are currently no other existing Bone Spring wells producing from within the proposed spacing unit.

The non-standard proration unit is necessary in order to maximize the recovery of oil and gas reserves from the Bone Spring formation underlying all of Sections 6 & 5, T-18-S, R-31-E, Eddy County, New Mexico.

The affected offset acreage comprises the SW/4SW/4 of Section 33, S/2S/2 of Section 32, and the S/2S/2 of Section 31 all in T17S-R31E, the N/2S/2 of Section 5, N/2S/2 of Section 6, and the W/2NW/4 & NW/4SW/4 of Section 4 all in T18S-R31E, and the E/2NE/4 & NE/4SE/4 of Section 1 in T18S-R30E, and the SE/4SE/4 of Section 36 in T17S-R30E, Eddy County, New Mexico. There is currently Bone Spring production within the offset acreage. Consequently, notice of this application is being provided to all parties listed on the attached list of affected parties.

Attached are the Form C-102s showing the surface, first take point, and bottomhole locations for the Fresh Squeezed 6/5 Fed Com #521H, #523H, & #404H. Also, attached is a map showing the affected offset acreage, a horizontal well plan, notice list and offset notice letter.

Mewbourne is seeking approval of this NSP to eliminate the need for separate production facilities and additional administrative approvals. Therefore, reducing waste while protecting correlative rights within the referenced horizontal spacing unit.

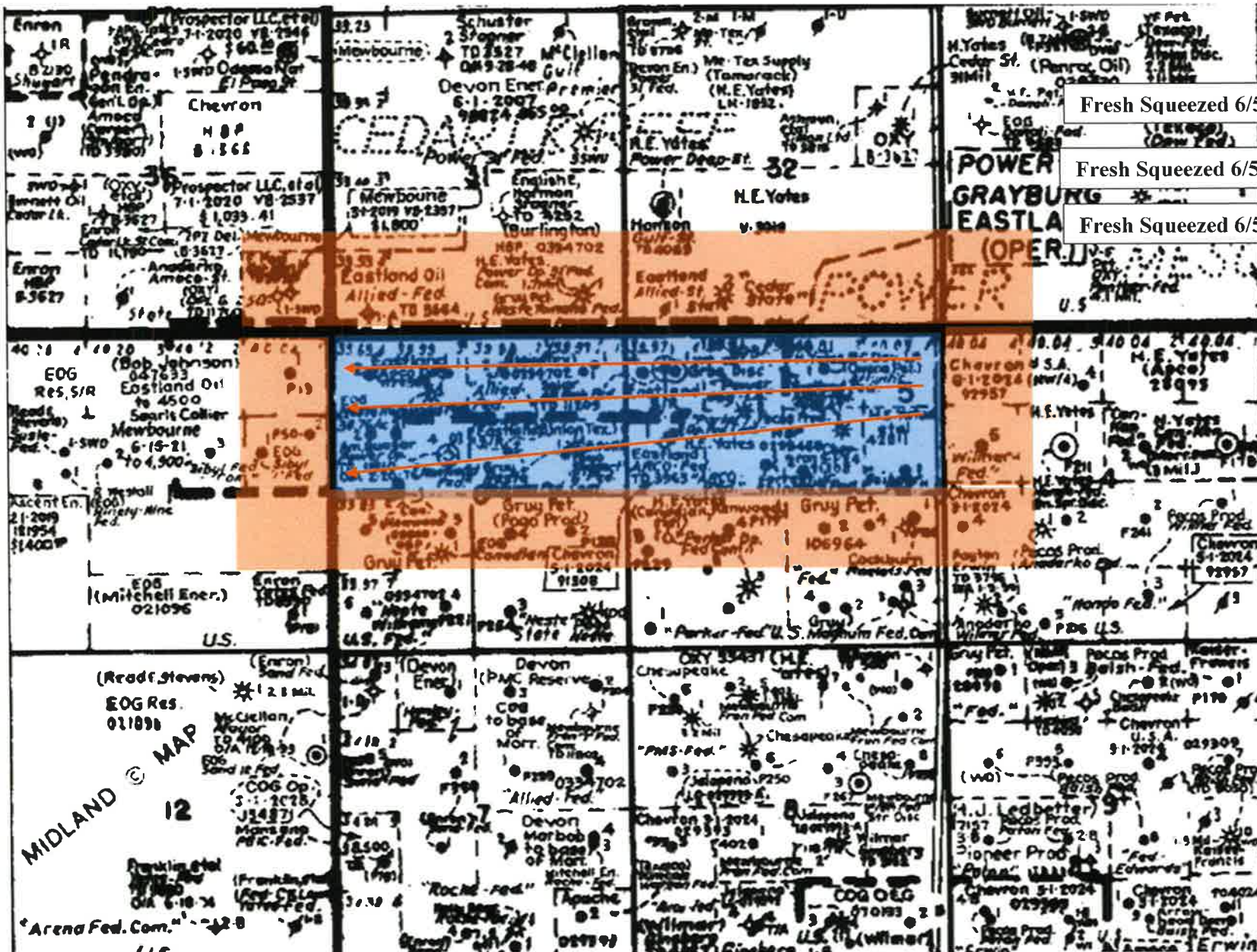

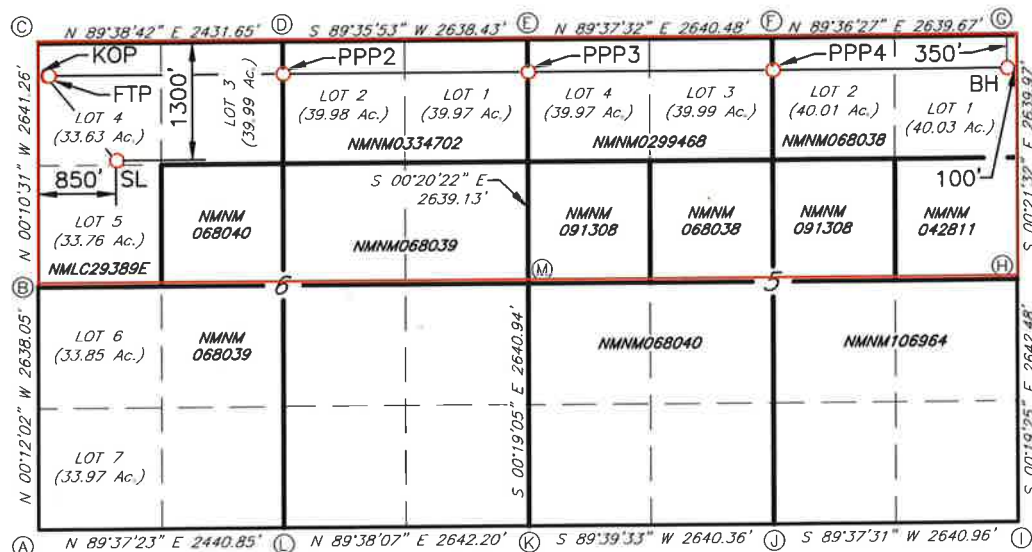
