You have requested to complete this horizontal well described above in the referenced pool or formation. This well is governed by special rules R-14262, for the Purple Sage; Wolfcamp (Gas) Pool and governs wells to be located at least 330 feet from the unit outer boundary of a spacing unit and no closer than 10 feet to any quarter – quarter section line. The completed intervals of

horizontal wells are to be located no closer than 330 feet to the exterior boundary of a standard 320 - acre spacing unit.

The request to deviate from an orthodox location has met all requirements of 19.15.16.15 (C)(5)(a) NMAC. It is understood that you are seeking this exception in order to create a non-standard location, comprised of First and Last Take Points referenced above within the described Horizontal Spacing Unit.

The well's completed interval is as close as 143 feet to southern boundary and 131 from the northern edge of the horizontal spacing unit. Encroachment will impact the following tract(s).

Section 01, T26S, R31E, encroachment to the NW/4  
Section 25, T25S, R31E, encroachment to the NW/4

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in Paragraph (8) Subsection A of 19.15.2.7 NMAC, in all adjoining units towards which the proposed location encroaches.

Division understands you are seeking this unorthodox location in order to maximize the recovery of oil and gas reserves within the Wolfcamp formation underlying the W/2 of Section 36 and the SW/4 of Section 25, thereby protecting correlative rights of all affected.

Your application has been filed under 19.15.16.15(C)(6) NMAC, 19.15.15.13 NMAC and 19.15.4.12 (A)(2) NMAC.

Per Subsection B of 19.15.15.13 NMAC, **Division approves this unorthodox location.**

Reference this NSL order number on the As Drilled C-102 submitted with the Authorization to Transport, to place this well into production.



Dear Mr. Lowe:

Pursuant to Division Rule 19.15.15.13, Mewbourne Oil Company (“Mewbourne”) respectfully requests administrative approval of an unorthodox gas well location for its proposed BEBOP 36/25 W1NK FED COM #2H well. This well will be drilled as a horizontal gas well in the Purple Sage; Wolfcamp (Gas), Pool Code (98220).

The BEBOP 36/25 W1NK FED COM #2H well will be dedicated to a 480-acre gas spacing and proration unit comprising the SW/4 of Section 25 and W/2 of Section 36, T25S, R31E, NMPM, Eddy County, New Mexico.

The Purple Sage; Wolfcamp (Gas), Pool Code (98220) is currently governed by Division Rule 19.15.15.10 which requires standard 320-acre gas spacing and proration units with wells to be located no closer than 330 feet to the outer boundary of the spacing unit, nor closer than 10 feet to any interior quarter-quarter section line or subdivision inner boundary, or in the case of a horizontal well, no closer than 330 feet to the outer boundary of the producing area.

The unorthodox location is necessary in order to maximize the recovery of oil and gas reserves from the Wolfcamp formation underlying SW/4 of Section 25 and W/2 of Section 36, T25S, R31E, NMPM, Eddy County, New Mexico.


The affected offset acreage comprises of NW/4 of Section 25, T25S, R31E, NMPM, Eddy County, New Mexico and the NW/4 of Section 1, T26S, R31E, NMPM, Eddy County, New Mexico (See Attached Map). Notice of this application is being provided to the attached list of parties.

Enclosed is a Form C-102 showing the surface, first take point, and bottomhole locations for the BEBOP 36/25 WINK FED COM #2H well. Also, attached is a map showing the affected offset acreage, notice letter and offset notice list of parties and their addresses.

In summary, approval of the application will provide Mewbourne Oil Company the opportunity to recover additional oil and gas reserves from the Purple Sage; Wolfcamp (Gas), Pool Code (98220) underlying the SW/4 of Section 25 and W/2 of Section 36, T25S, R31E, NMPM, Eddy County, New Mexico that may otherwise not be recovered, thereby preventing waste, and will not violate correlative rights.

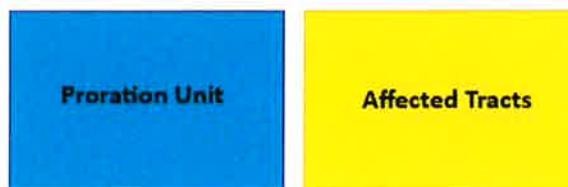
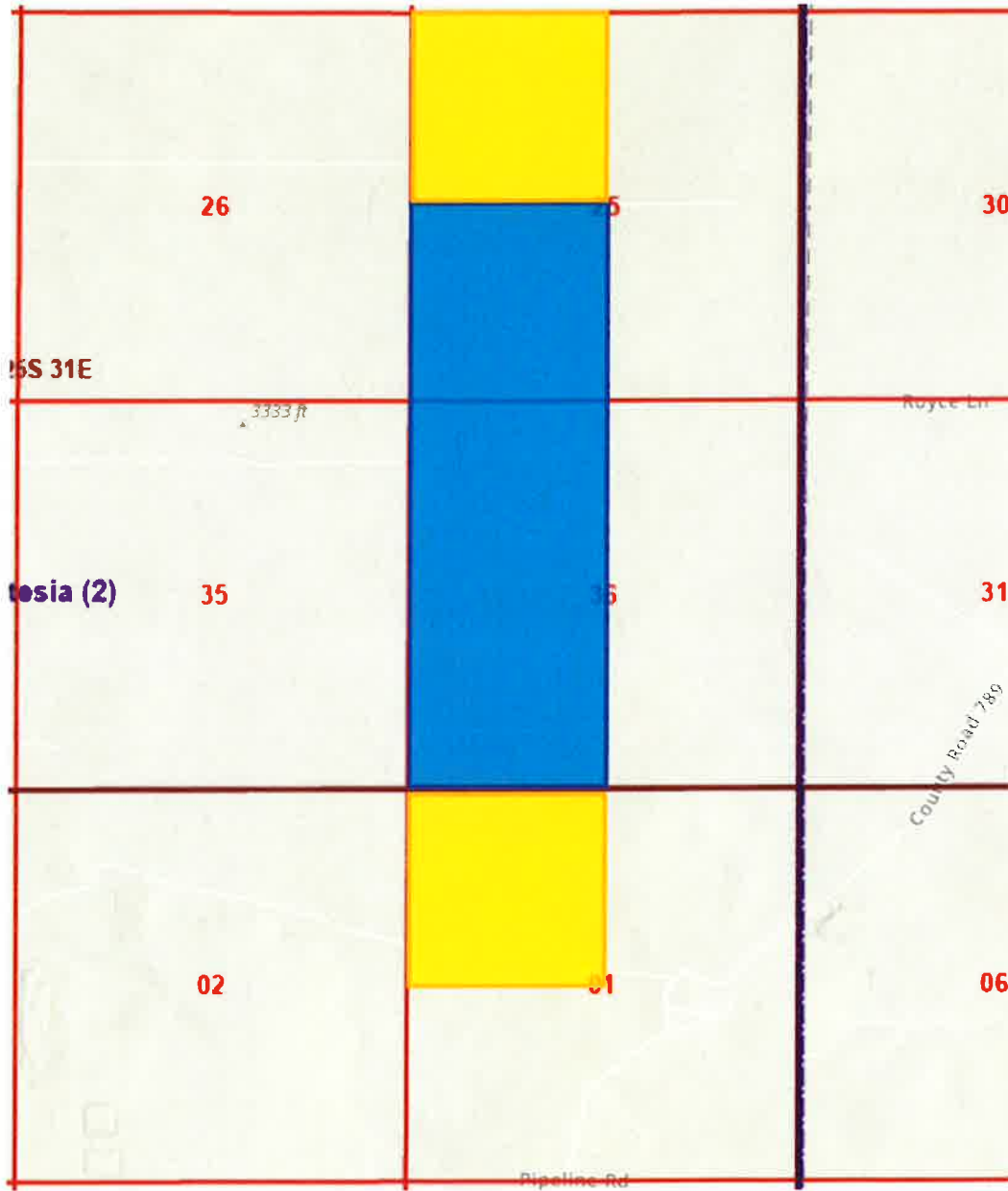

Eddy County, NM



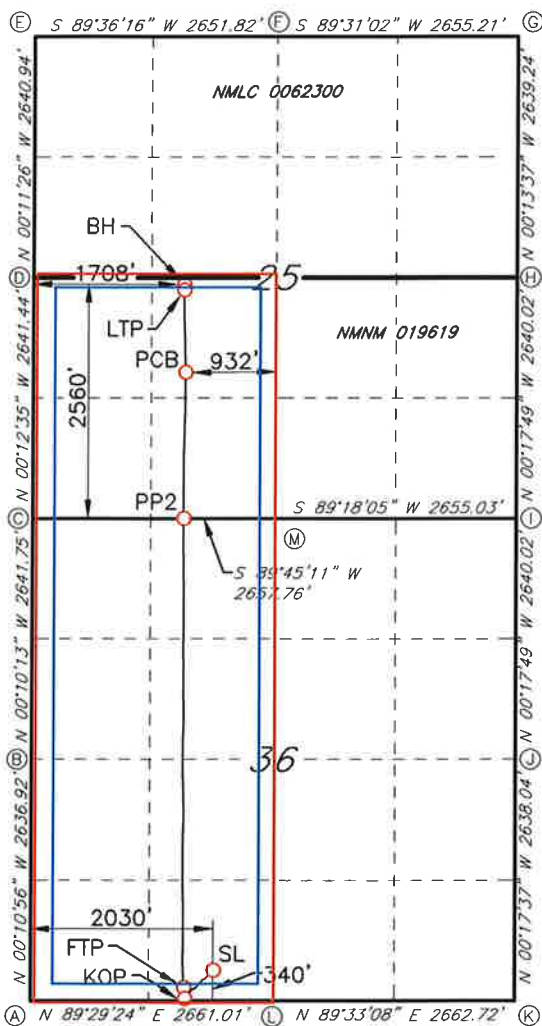


ACREAGE DEDICATION PLATS
