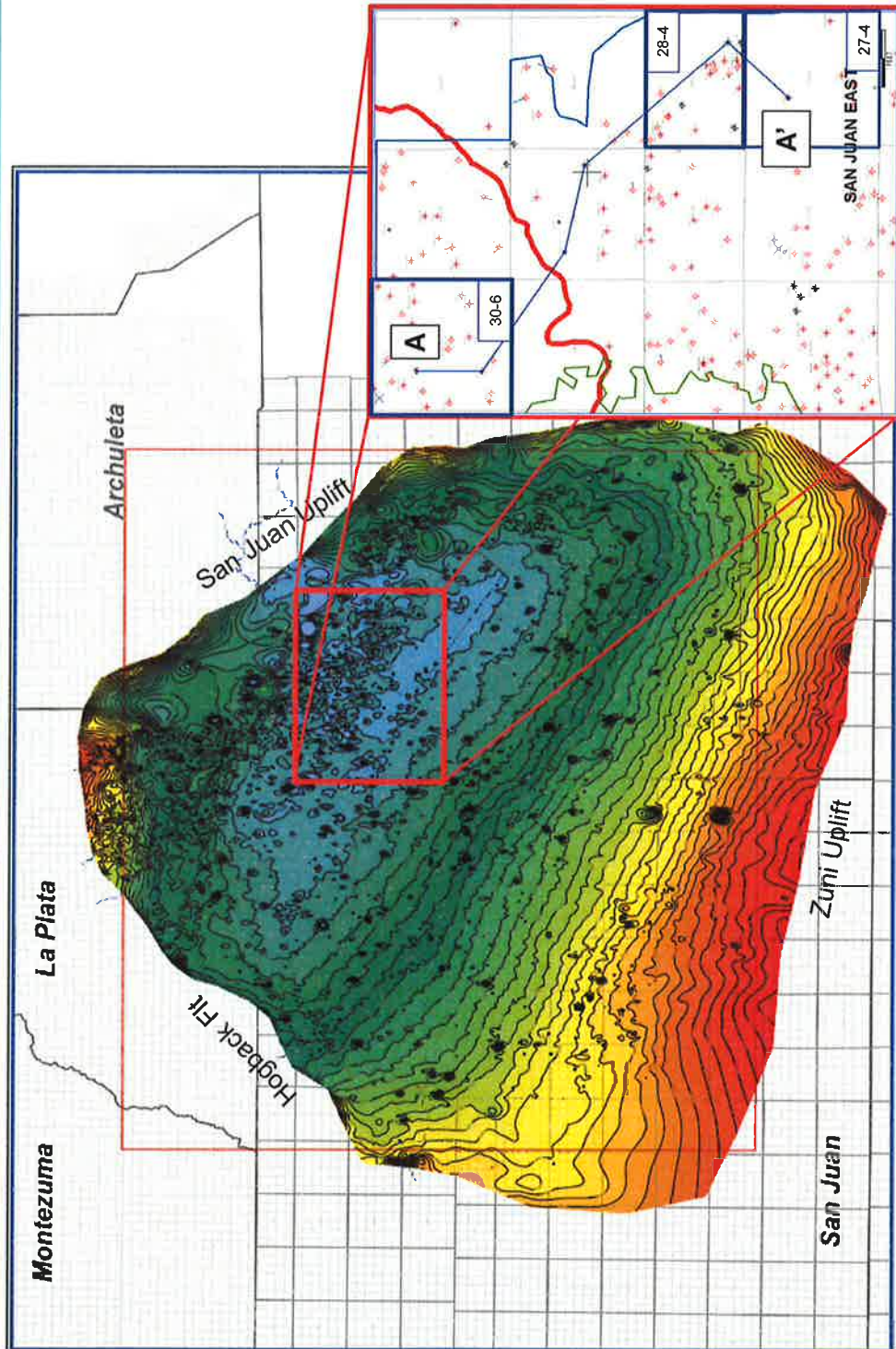


Regional Type Log



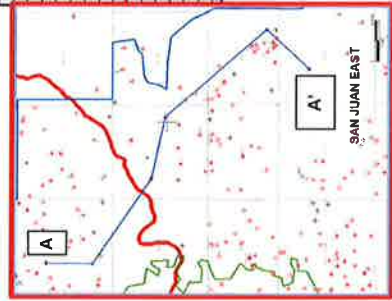
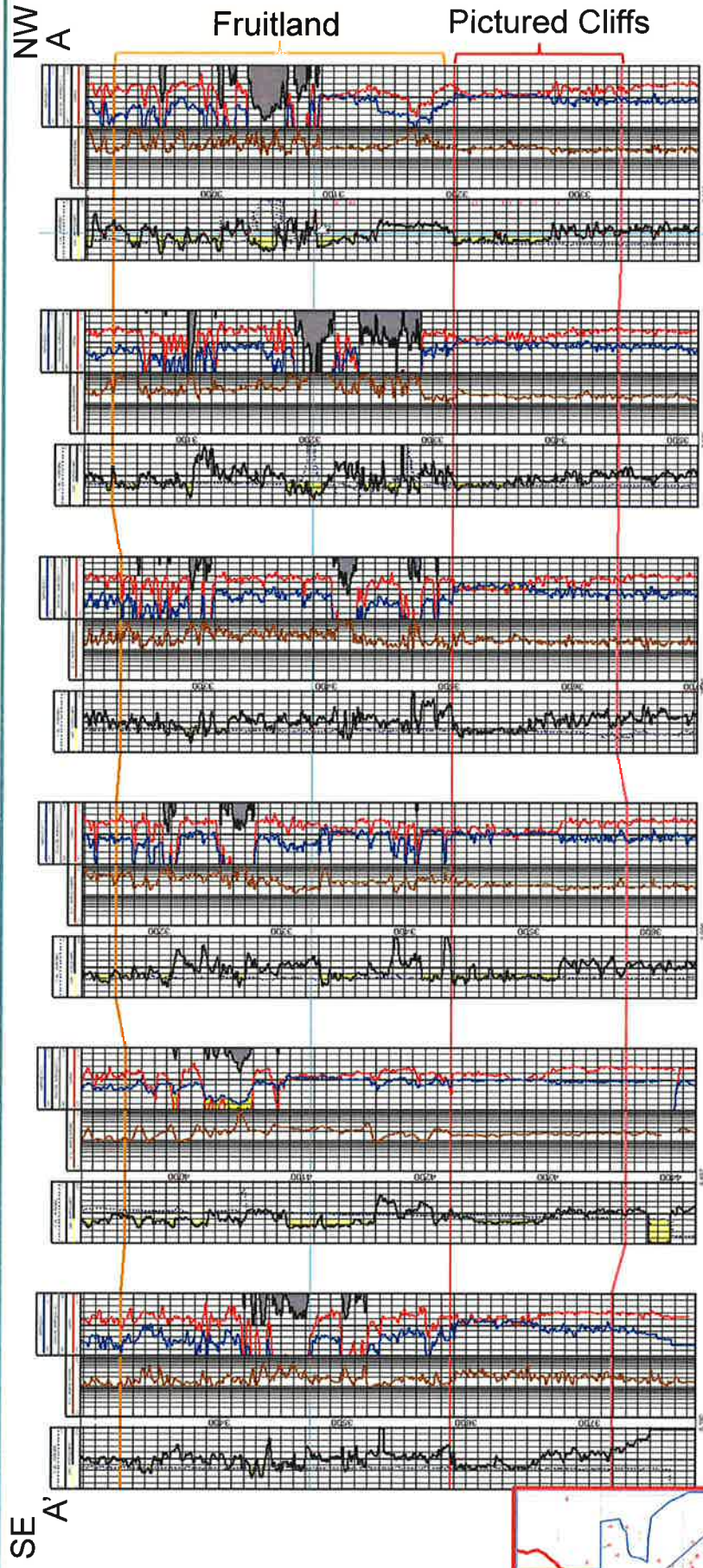


Pictured Cliffs Structure





Stratigraphic Cross-Section

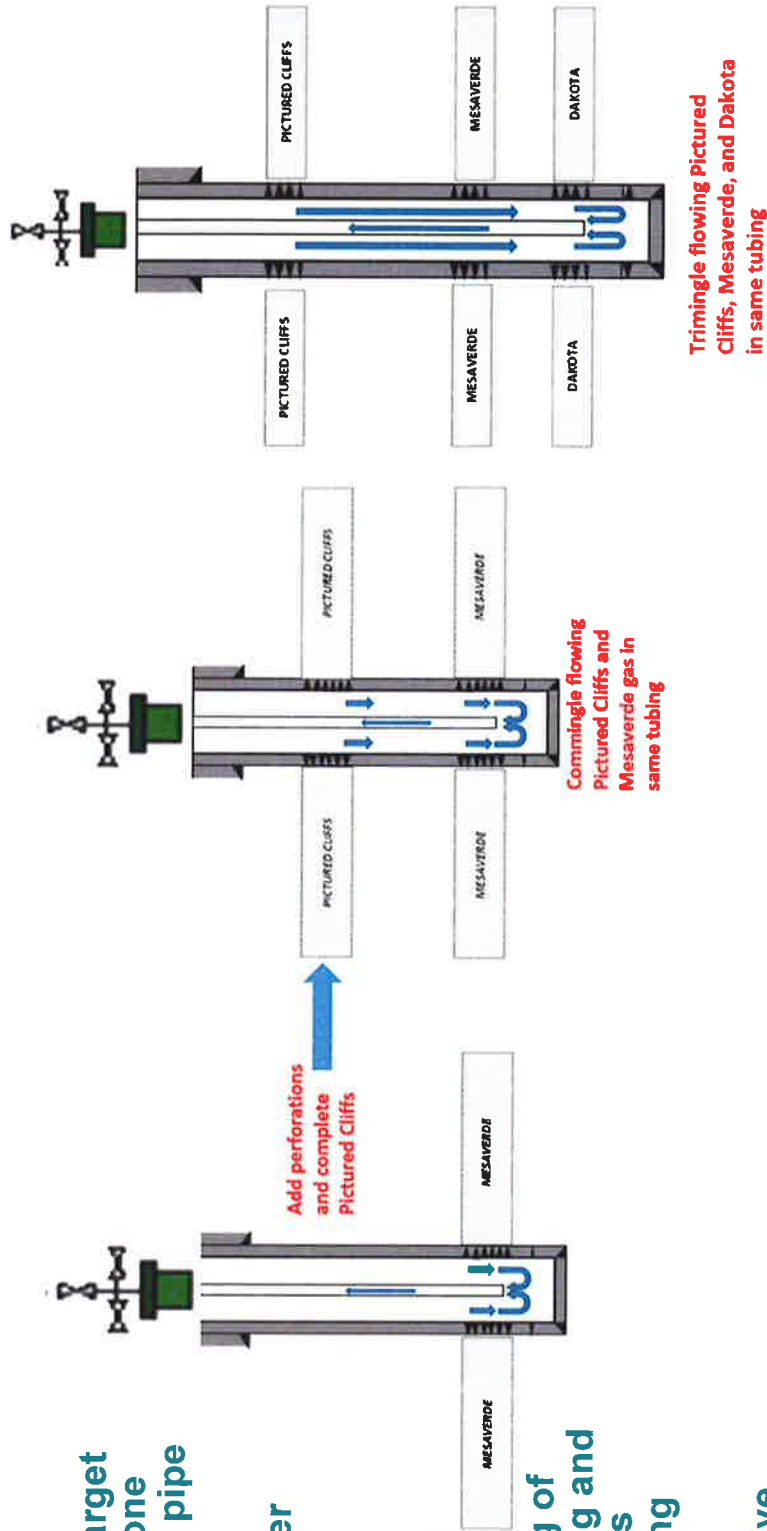

- **PC Concepts**
 - 800+ PC commingles
 - PC & MV gas quality is similar
 - Commingled wells show higher margin
