Page 3 HEARING EXAMINER COSS: Now the Division will 1 2 call Case Number 20936, Matador Energy for compulsory 3 pooling. Entries of appearance? 4 MS. LUCK: Kaitlyn Luck with the Santa Fe office 5 of Holland & Hart on the behalf of the applicant Matador 6 Resources Company. 7 HEARING EXAMINER COSS: Any other entries of 8 appearance in this case? 9 MS. HARDY: Yes. Dana Hardy with the Santa Fe 10 office of Hinkle Shanor on behalf of Alpha Limited Partners and Mewbourne Oil Company. I do not object to the case 11 12 being presented by affidavit based on my understanding that 13 Mewbourne and Alpha are not being pooled and that's 14 reflected in the exhibits. MS. LUCK: That is correct. That's the agreement 15 that Matador Production Company has reached in this case, so 16 17 we are not seeking to pool Mewbourne or Alpha. In this case Matador filed an application for 18 compulsory pooling in Eddy County, New Mexico, seeking an 19 order pooling all uncommitted interest owners in the 20 Wolfcamp Formation underlying a standard 480 acre horizontal 21 spacing unit comprised of the NE/4 of Section 29 and the  $\ensuremath{\text{E}/2}$ 22 of Section 20, Township 22 South, Range 27 East, Eddy 23 24 County, New Mexico, and it seeks to dedicate the proposed 25 spacing unit to the Betty Jones Com 203H well.

In front of you in your packet are affidavits of 1 2 the landman, which is Exhibit A, the affidavit of the geologist, which is Exhibit B, and notice affidavit, which 3 4 is Exhibit C. That affidavit provides that our office provided notice of this hearing to the parties to be pooled, 5 and behind C1 is the affidavit of the publication reflecting 6 7 that the case was published in Eddy County in an abundance 8 of caution to be sure all parties were provided notice of 9 this hearing. 10 And just one more point. Our Exhibit A3 is the

exhibit that reflects that the parties that Matador is seeking to pool in this case which does not include either Mewbourne or Alpha. So with that I would request that the exhibits be accepted into the record and the case be taken under advisement.
