1 HEARING EXAMINER COSS: And at this point I would
2 liable to like to call case Number 20938, Chisholm Energy
3 for compulsory pooling.

4 MS. LUCK: Kaitlyn Luck on behalf the applicant,
5 Chisholm Operating Energy.

6 HEARING EXAMINER COSS: You may proceed.

7 MS. LUCK: Thank you. Again in this case
8 Chisholm Energy Operating intends to present this case by
9 affidavit, so before you there is an exhibit and affidavit
10 packet with three affidavits.

11 The first is the land affidavit behind Exhibit A.
12 The next one is the geologist affidavit behind Exhibit B,
13 and finally the notice affidavit behind Exhibit C, followed
14 by the notice of publication behind C1.

15 In this case Chisholm Energy Operating has
16 applied for compulsory pooling in Eddy County, New Mexico,
17 and is seeking an order pooling all uncommitted interests in
18 the Wolfcamp formation underlying a standard 480 acre
19 horizontal spacing unit comprised of the E/2 of Section 15,
20 and NE/4 of Section 22, Township 23 South, Range 26 East,
21 and this is in Eddy County.

22 So behind Tab C you will find the notice
23 affidavit which confirms that our office provided notice of
24 this hearing to the parties to be pooled. And out of an
25 abundance of caution, we also published notice, which is

1 behind C1.

2 So with that I ask that the Division accept the
3 records into the record and take the case under advisement.

4 (Exhibits A, B, C and D offered.)

5 HEARING EXAMINER COSS: Wonderful. Thank you.
6 The Division will take Case Number 20938 under advisement.

7 MS. LUCK: Thank you.
