

**APPLICATION**

San Juan Resources, Inc. (“SJR”) files this application to amend Order R-22053 to correct the acreage description for the approved Lindrith East (Deep) Unit. In support of its application, SJR states:

1. The Lindrith East (Deep) Unit consists of approximately 8,800-acres of the following federal and fee lands situated in Rio Arriba County, New Mexico:

**Township 24 North, Range 2 West, N.M.P.M.**

- Section 10: NE/4, E/2SE/4
- Section 11: ALL
- Section 12: ALL
- Section 13: ALL
- Section 14: ALL
- Section 15: N/2NE/4, SE/4
- Section 22: E/2
- Section 23: ALL
- Section 24: ALL
- Section 25: ALL
- Section 26: ALL
- Section 27: ALL
- Section 33: S/2
- Section 34: ALL
- Section 35: ALL
- Section 36: ALL

2. SJR is the designated operator under the approved Unit Agreement and the unitized interval is all formations below the Top of the Mancos Formation, which is defined as the stratigraphic equivalent of 5,820 feet MD in the Amoco Federal Oso #1 well

located in the NW/4, Section 24, Township 24 North, Range 2 West, N.M.P.M., Rio Arriba County, New Mexico (API#30-039-26672).

3. Division Order R-22053 (issued in Case No. 22399) mistakenly omits the S/2 SE/4 of Section 15, Township 24 North, Range 2 West, from the description of the unitized area. This omission was prompted by the same omission in the application and affidavit filed by SJR in Case No. 22399.

4. The Unit Agreement and the other information submitted in Case 22399 correctly describes the acreage in the approved unit, which has likewise been recognized and approved by the Bureau of Land Management.

5. This application to correct the acreage description in Order R-22053 is consistent with the record presented in Case 22399 and the intent of the parties.

WHEREFORE, SJR requests that this Application be set for hearing before an Examiner of the Oil Conservation Division on July 7, 2022, and that after notice and hearing as required by law, the Division enter its order modifying Order R-22053 to correctly reflect the unitized acreage.
