**SUPPLEMENTAL AFFIDAVIT OF LACI STRETCHER**

Laci Stretcher, being first duly sworn upon oath, deposes and states as follows:

1. My name is Laci Stretcher, and I am employed by EOG Resources, Inc. (“EOG”) as a Senior Landman.

2. I have previously testified before the New Mexico Oil Conservation Division (“Division”) as an expert witness in petroleum land matters. My credentials in petroleum land matters have been accepted by the Division and made a matter of record.

3. I am submitting this supplemental affidavit in support of EOG’s application in the above-referenced case pursuant to 19.15.4.12.(A)(1) NMAC.

4. I am familiar with the application filed by EOG in this case, and I am familiar with the status of the lands in the subject area.

5. My affidavit dated September 29, 2022, submitted in support of the application in this case, contained certain inaccuracies pertaining to overlapping spacing units in the Bone Spring formation. This supplemental affidavit is submitted in correction of such inaccuracies. A correct description of such overlapping spacing units is as follows:

a. A spacing unit in the W/2W/2 of Section 35, dedicated to the Orange Raider BPV State No. 1H well (API No. 30-025-39712), in the Red Hills; Bone Spring, East Pool. EOG provided notice of the overlapping spacing unit to Oxy Y-1 Company and Sharbro Energy, LLC as the working interest owners. After twenty days, no objection was received.

b. A spacing unit in the W/2W/2 of Section 2, dedicated to the Tumbling Dice 2 State Com No. 1H well (API No. 30-025-41459) in the Red Hills; Upper Bone Spring Shale Pool. No notice was provided because EOG owns 100 percent of the interest in this spacing unit and is the operator of the well.

6. Though the original affidavit identified the incorrect spacing units, notice was sent out to the correct parties (Oxy Y-1 Company, Sharbro Energy, LLC, and the New Mexico State Land Office) for the spacing units identified above in advance of the hearing on October 6, 2022.

7. I hereby swear that to the best of my knowledge and belief, all of the matters set forth herein and in the exhibits are true, correct, and accurate.


