APPLICANT

Resources, Inc. seeks an order pooling all uncommitted mineral interest owners in the Bone Spring formation underlying a horizontal spacing unit comprised of the W/2W/2 of Section 13 and the W/2W/2 of Section 24, Township 19 South, Range 33 East, NMPM. The unit will be dedicated to the Millie Mile 13-24 Fed. Com. Well Nos. 101H and 201H, with first take points in the NW/4NW/4 of Section 13 and last take points in the SW/4SW/4 of Section 24.

(b) Case No. 23330: E.G.L. Resources, Inc. seeks an order pooling all uncommitted mineral interest owners in the Bone Spring formation in a horizontal spacing unit comprised of the E/2W/2 of Section 13 and the E/2W/2 of Section 24, Township 19 South, Range 33 East, NMPM. The unit will be dedicated to the Millie Mile 13-24 Fed. Com. Well Nos. 102H and 202H, with first take points in the NE/4NW/4 of Section 13 and last take points in the SE/4SW/4 of Section 24.

(c) Case No. 23331: E.G.L. Resources, Inc. seeks an order pooling all uncommitted mineral interest owners in the Wolfcamp formation in a horizontal spacing unit comprised of the

W/2W/2 of Section 13 and the W/2W/2 of Section 24, Township 19 South, Range 33 East, NMPM. The unit will be dedicated to the Millie Mile 13-24 Fed. Com. Well No. 401H, with a first take point in the NW/4NW/4 of Section 13 and a last take point in the SW/4SW/4 of Section 24.

(d) Case No. 23332: E.G.L. Resources, Inc. seeks an order pooling all uncommitted mineral interest owners in the Wolfcamp formation in a horizontal spacing unit comprised of the E/2W/2 of Section 13 and the E/2W/2 of Section 24, Township 19 South, Range 33 East, NMPM. The unit will be dedicated to the Millie Mile 13-24 Fed. Com. Well No. 402H, with a first take point in the NE/4NW/4 of Section 13 and a last take point in the SE/4SW/4 of Section 24.

Also to be considered will be the cost of drilling, completing, testing, and equipping the wells and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the wells, and a 200% charge for the risk involved in drilling, completing, testing, and equipping the wells.


