APPLICANT'S STATEMENT OF THE CASE

In Case No. 23556, Devon seeks an order (1) establishing a standard 640-acre, more or less, spacing and proration unit comprised of the S/2 of Sections 35 and 36, Township 20 South, Range 29 East, NMPM, Eddy County, New Mexico, and (2) pooling all uncommitted mineral interests in the Bone Spring formation, designated as an oil pool, underlying said unit. Devon proposes and dedicates to the HSU the **Tambora 36-35 Fed Com 333H Well** and the **Tambora 36-35 Fed Com 332H Well**, as initial wells, to be drilled to a sufficient depth to test the Bone Spring formation.

Devon proposes the **Tambora 36-35 Fed Com 333H Well**, an oil well, to be horizontally drilled from a surface location in SE/4 SE/4 (Unit P) of Section 36 to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 35. The **Tambora 36-35 Fed Com 333H Well** is a proximity well, positioned so the unit can include proximity tracts located within 330 feet of the well's completed interval, thereby incorporating the N/2 S/2 of Sections 35 and 36, in order to establish the larger unit covering the S/2 of said Sections.

Devon proposes the **Tambora 36-35 Fed Com 332H Well**, an oil well, to be horizontally drilled from a surface location in the SE/4 SE/4 (Unit P) of Section 36 to a bottom hole location in the NW/4 SW/4 (Unit L) of Section 35.

The **Tambora 36-35 Fed Com 333H Well** is orthodox in its location, and the take points and completed interval comply with setback requirements under the statewide rules. However, the **Tambora 36-35 Fed Com 332H Well** is unorthodox in its location, and Devon will be applying administratively for approval of the nonstandard location (NSL).
