**STATEMENT OF THE CASE**

In **Case No. 23666**, Colgate applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the N/2 NW/4 of Section 29 and the N/2 N/2 of Section 30, Township 18 South, Range 31 East, Eddy County, New Mexico. The spacing unit will be dedicated to the following wells:

- **Long John 29-30 Fed Com 121H** well, which will be drilled from a surface hole location in the NE<sup>4</sup> NW<sup>4</sup> (Unit C) of Section 29 to a bottom hole location in the NW<sup>4</sup> NW<sup>4</sup> (Unit D) of Section 30; and
- **Long John 29-30 Fed Com 131H** well, which will be drilled from a surface hole location in the NW<sup>4</sup> NE<sup>4</sup> (Unit B) of Section 29 to a bottom hole location in the NW<sup>4</sup> NW<sup>4</sup> (Unit D) of Section 30.

In **Case No. 23667**, Colgate applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the S/2 NW<sup>4</sup> of Section 29 and the S/2 N/2 of Section 30, Township 18 South, Range 31 East, Eddy County, New Mexico. The spacing unit will be dedicated to the following wells:

- **Long John 29-30 Fed Com 122H** well, which will be drilled from a surface hole location in the NE<sup>4</sup> NW<sup>4</sup> (Unit C) of Section 29 to a bottom hole location in the SW<sup>4</sup> NW<sup>4</sup> (Unit E) of Section 30; and
- **Long John 29-30 Fed Com 132H** well, which will be drilled from a surface hole location in the NW<sup>4</sup> NE<sup>4</sup> (Unit B) of Section 29 to a bottom hole location in the SW<sup>4</sup> NW<sup>4</sup> (Unit E) of Section 30.

The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Permian Resources as operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells. The wells are located approximately 30.56 miles southeast of Artesia, New Mexico.
