RESPONSE OF CIMAREX TO MOTION FOR CONTINUANCE, AND MOTION TO DISMISS OBHECTION

Realeza Del Spear (Spear) has filed a motion for a continuance, and an objection to proceeding by affidavit. Cimarex Energy Co. ("Cimarex") requests that the motion be denied and the objection be dismissed for the very simple reason discussed briefly below:

Spear claims that Cimarex has not engaged in communications with Spear, and it only has recent knowledge of the application.

Please see the e-mail attached hereto as **Exhibit 1**. First, it shows that Spear has known of this matter for over 1-1/2 years. More importantly, Spear states that it has leased its mineral interest to Del Rey Holdings. As a royalty owner Cimarex did not need to negotiate with Spear, it is not being pooled, and it has no standing to object or file its motion.

Del Rey Holdings was notified of this hearing, as will be shown by the exhibits presented. The undersigned mistakenly did not remove Spear's name from the notice list. Notice was recently given (again) to working interest owners as a matter of courtesy simply because the case has been pending for a long time.

WHEREFORE, Cimarex requests that the motion be denied and the objection be dismissed.
