APPLICANT'S STATEMENT OF THE CASE

Under **Case No. 24010**, MRC seeks an order pooling all uncommitted interest in a standard 400-acre, more or less, horizontal well spacing unit in the Wolfcamp (WC-025 G-10 S213328O;WOLFCAMP [98033]) formation underlying the W/2 W/2 of Section 6, Township 22 South, Range 33 East, and the W/2 W/2 of Section 31 and the W/2 SW/4 of Section 30, Township 21 South, Range 33 East, NMPM, Lea County, New Mexico. This spacing unit will be initially dedicated to the proposed **Paul Flowers State Com 205H** well to be horizontally drilled from a

surface hole location in the SW/4 of Section 6, with a first take point in the SW/4 SW/4 equivalent (Lot 7) of section 6 and a last take point in the NW/4 SW/4 (Unit L) of Section 30.

The completed interval for the well will comply with statewide setbacks for oil wells. MRC has sought and been unable to obtain voluntary agreement for the development of these lands from all interest owners in the subject acreage.
