**APPLICANT'S STATEMENT OF THE CASE**

In these consolidated cases Devon seeks orders pooling four 160-acre horizontal well spacing unit in the Bone Spring formation underlying Section 16, Township 23 South, Range 31 East, NMPM, Eddy County, New Mexico, as follows:

- **Case 24191** seeks to pool the W2W2 of Section 16 to be initially dedicated to the proposed **Cat Island 16 State 231H** well, to be horizontally drilled from a

surface location in the SE4SW4 of Section 16, with a first take point in the SW4SW4 (Unit M) and a last take point in the NW4NW4 (Unit D).

- **Case 24192** seeks to pool seeks to pool the E2W2 of Section16 to be initially dedicated to the proposed **Cat Island 16 State 232H** well, to be horizontally drilled from a surface location in the SE4SW4 of Section 16, with a first take point in the SE4SW4 (Unit N) and a last take point in the NE4NW4 (Unit C).
- **Case 24193** seeks to pool seeks to pool the W2E2 of Section16 to be initially dedicated to the proposed **Cat Island 16 State 233H** well, to be horizontally drilled from a surface location in the SE4SW4 of Section 16, with a first take point in the SW4SE4 (Unit O) and a last take point in the NW4NE4 (Unit B).
- **Case 24194** seeks to pool seeks to pool the E2E2 of Section16 to be initially dedicated to the proposed **Cat Island 16 State 234H** well, to be horizontally drilled from a surface location in the SE4SW4 of Section 16, with a first take point in the SE4SE4 (Unit P) and a last take point in the NE4NE4 (Unit A).

Devon has sought but been unable to obtain voluntary agreement for the development of this acreage all affected mineral owners.
