STATEMENT OF THE CASE

E.G.L. seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 640-acre, more or less, standard horizontal spacing unit comprised of the E/2 of Sections 24 and 25, Township 18 South, Range 32 East, Lea County, New Mexico ("Unit"). The Unit will be dedicated to the following proposed wells ("Wells"):

- a. the **LTK 24-25 Fed Com 101H, 102H, 201H, and 203H Wells**, to be drilled from a surface hole location in the NE/4 NE/4 (Unit A) of Section 24 to a bottom hole location in the SW/4 SE/4 (Unit O) of Section 25; and
- b. the **LTK 24-25 Fed Com 103H and 205H Wells**, to be drilled from a surface hole location in the NE/4 NE/4 (Unit A) of Section 24 to a bottom hole location in the SE/4 SE/4 (Unit P) of Section 25.

The completed intervals of the Wells will be orthodox. The completed interval of the **LTK 24-25 Fed Com 203H Well** will be located within 330' of the quarter-quarter section line separating the E/2 E/2 and W/2 E/2 of Sections 24 and 25 to allow for the creation of a 640-acre standard horizontal spacing unit.

Also to be considered will be the cost of drilling and completing the Wells and the allocation of the costs and a 200% charge for the risk involved in drilling and completing the Wells. The Wells are located approximately 8 miles south of Maljamar, New Mexico.
