### **STATEMENT OF THE CASES**

In **Case No. 24821**, Applicant requests that the Division issue an order granting a one-year extension of time, until December 1, 2025, to commence drilling the well authorized by Order No. R-22960. The order: approved a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 N/2 of Sections 35 and 36, Township 19 South, Range 29 East, Eddy County, New Mexico; pooled uncommitted interests within the First and Third intervals of the Bone Spring Formation underlying the unit; dedicated the unit to the **Ironhorse 35-36 Fed State #131H** well; and designated Applicant as operator of the unit and well.

In **Case No. 24822**, Applicant requests that the Division issue an order granting a one-year extension of time, until December 1, 2025, to commence drilling the well authorized by Order No. R-22961. The order: approved a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2 N/2 of Sections 35 and 36, Township 19 South, Range 29 East, Eddy County, New Mexico; pooled uncommitted interests within the First and Third intervals of the Bone Spring Formation underlying the unit; dedicated the unit to the **Ironhorse 35-36 Fed State #132H** well; and designated Applicant as operator of the unit and well.

Good cause exists for the requested extensions because Applicant's ability to commence drilling the wells has been impacted by changes in its development plan and the need to co-develop these units with offset acreage to best prevent waste and protect correlative rights. Although Permian Resources' applications sought to pool additional uncommitted interests under the terms of the above-referenced orders, that request is no longer necessary and is being withdrawn.
