STATEMENT OF THE CASES

In Case Nos. 25208 and 25209, Steward applies to the Division for an order approving a one-year extension of time to commence drilling the wells authorized by Order Nos. R-23160 and R-23161.

The Division issued Order No. R-23160 in Case No. 24172 on April 17, 2024, pooling all uncommitted interests in the San Andres Formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the E/2 W/2 of Sections 10 and 15, Township 13 South, Range 38 East, Lea County, New Mexico, and dedicated the Unit to the Blue Sky Fee 4H well, and designated Steward as operator of the Unit and the Well.

The Division issued Order No. R-23161 in Case No. 24173 on April 17, 2024, pooling all uncommitted interests in the San Andres formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the W/2 W/2 of Sections 10 and 15, Township 13 South, Range 38 East, Lea County, New Mexico, and dedicated the Unit to the Blue Sky Fee 6H well, and designated Steward as operator of the Unit and the Well.

Order Nos. R-23160 and R-23161 require Steward to commence drilling the Wells within one (1) year of the date of the Orders unless good cause is shown. Good cause exists for the requested extension because Steward is evaluating drilling results from offset acreage to determine optimal well spacing in the area. Therefore, Steward requests that the Division extend the deadline to drill the Blue Sky 4H and 6H wells until April 17, 2026.
