**APPLICANT’S STATEMENT OF THE CASE**

In Case No. 25201, WPX seeks an order pooling all uncommitted mineral interests in the Bone Spring formation, designated as an oil pool, underlying a standard 320-acre, more or less, spacing unit comprised of the S/2 N/2 of Sections 32 and 33, Township 23 South, Range 26 East, NMPM, Eddy County, New Mexico

1. WPX is a working interest owner in the proposed horizontal spacing and proration unit (“HSU”) and has a right to drill a well thereon.
2. WPX proposes and dedicates to the HSU the **Frontier 33-32 State Fed Com 222H Well**, as the initial well, to be drilled to a sufficient depth to test the Bone Spring formation.
3. WPX proposes the **Frontier 33-32 State Fed Com 222H Well**, an oil well, to be horizontally drilled from a surface location in the NE/4 NE/4 (Unit A) of Section 33 to a bottom hole location in the SW/4 NW/4 (Unit E) of Section 32.
4. The well proposed herein is orthodox in its location, and the take points and completed interval comply with setback requirements under statewide rules.
