**RESPONSE TO MOTION TO STRIKE**

MRC Permian Company (“MRC”) hereby submits this response to American Energy Resources, LLC’s (“American Energy”) motion to strike.

An operator that operates more than a thousand wells is out of compliance if the operator has more than ten wells that have not been properly plugged and abandoned in accordance with 19.15.25.8 NMAC. *See* 19.15.5.9(A)(4)(d) NMAC. The Division “makes available on its website, and update[s] daily, an ‘inactive well list.’” 19.15.5.9(B)(1) NMAC.

Matador Production Company (OGRID No. 228937) (“Matador”) is an affiliate of MRC and is the designated operator of its wells. The Division’s records show that Matador currently operates 1,749 wells in New Mexico and has six wells listed on the Division’s Inactive Well List. *See Exhibit A.* Matador is therefore in compliance with the Division rules and has standing to file the above-captioned pooling applications. If the Division has concerns about any of the wells that Matador operates, Matador is available to discuss and engage with the Division.

WHEREFORE, MRC respectfully requests that American Energy’s motion to strike be denied by the Division.
