**APPLICATION** 

XTO Energy, Inc. ("XTO" or "Applicant"), through its undersigned attorneys, hereby files this application with the Oil Conservation Division pursuant to the provisions of NMSA 1978, §

70-2-17, for an order pooling all uncommitted record title owners in the Wolfcamp formation

underlying a standard 447.9-acre, more or less, horizontal well spacing unit comprised of the W/2

of Section 25 and the N/2 NW/4 and Lots 1 and 2 (NW/4 equivalent) of irregular Section 36,

Township 26 South, Range 29 East, NMPM, Eddy County, New Mexico. In support of its

application, XTO states:

1. Applicant is a working interest owner in the proposed horizontal spacing unit and

has the right to drill thereon.

2. Applicant seeks to initially dedicate the above-referenced horizontal spacing unit

to the drilled and producing Ross Draw Federal Com 25-36 131H (API No. 30-015-45590) and

the Ross Draw 25-36 Federal Com 161H (API No. 30-015-45591) wells, both with surface

locations in the NW/4 NW/4 (Unit D) of Section 25, first take points in the NW/4 NW/4 (Unit D)

of Section 25 and last take points in Lot 1 (SW/4 NW/4 equivalent) of irregular Section 36; the

Ross Draw 25-36 Federal Com 102H (API No. 30-015-45585), Ross Draw 25-36 Federal Com

103H (API No. 30-015-45595), and Ross Draw 25-36 Federal Com 123H (API No. 30-015-

45596) wells, all with surface locations in the NE/4 NW/4 (Unit C) of Section 25, first take points

- 3. Applicant has sought and been unable to obtain the signatory approval on the state communization agreement from all the record title owners.
- 4. The pooling of record title owners will allow Applicant to obtain a just and fair share of the oil and gas underlying the subject lands, avoid the drilling of unnecessary wells, will prevent waste, and will protect correlative rights.

WHEREFORE, Applicant requests that this application be set for hearing before an Examiner of the Oil Conservation Division on September 11, 2025, and, after notice and hearing as required by law, the Division enter an order:

- A. Pooling all uncommitted record title owners in the horizontal spacing unit; and
- B. Designating Applicant as operator of this spacing unit and the horizontal wells drilled thereon.

SELF-AFFIRMED STATEMENT OF CHAD SMITH

1. My name is Chad Smith, and I am employed by XTO Energy Inc. ("XTO") as a

landman.

2. I have not previously testified before the New Mexico Oil Conservation Division

("Division") as an expert witness in petroleum land matters. I have included a copy of my resume

as XTO Exhibit C-1 for the Division to review and respectfully request that my credentials be

accepted as a matter of record, and that I be tendered as an expert in land matters.

3. I am familiar with the application filed by XTO in this case, and I am familiar with

the status of the lands in the subject area.

4. XTO seeks an order pooling all uncommitted record title owners in the Wolfcamp

formation underlying a standard 447.9-acre, more or less, horizontal well spacing unit comprised

of the W/2 of Section 25 and the N/2 NW/4 and Lots 1 and 2 (NW/4 equivalent) of irregular

Section 36, Township 26 South, Range 29 East, NMPM, Eddy County, New Mexico. XTO seeks

to initially dedicate the above-referenced horizontal spacing unit to the drilled and producing Ross

Draw Federal Com 25-36 131H (API No. 30-015-45590) and the Ross Draw 25-36 Federal

Com 161H (API No. 30-015-45591) wells, both with surface locations in the NW/4 NW/4 (Unit

D) of Section 25, first take points in the NW/4 NW/4 (Unit D) of Section 25 and last take points

in Lot 1 (SW/4 NW/4 equivalent) of irregular Section 36; the Ross Draw 25-36 Federal Com

- 5. **XTO Exhibit C-2** contains a Form C-102 for the wells. This form demonstrates that the wells are in the Purple Sage; Wolfcamp (Gas) [98220]. The completed interval for all the wells (except the Ross Draw 25-36 Federal Com 103H) meet the Purple Sage Special Pool Rules; the Ross Draw 25-36 Federal Com 103H has an approved non-standard well location (NSL-8092).
- 6. **XTO Exhibit C-3** identifies the tracts of land comprising the spacing unit and the lateral of the Ross Draw 25-36 Fed 122H. The acreage is comprised of state and federal lands.
- 7. XTO has reached a voluntary agreement with all working interest owners in this unit but seeks a pooling order for record title owners, which are non-cost bearing interest owners, who have yet to execute the necessary state communitization agreement. The parties that XTO seeks to pool are highlighted in yellow in XTO Exhibit C-3.
- 8. XTO has reviewed public records, conducted online computer searches and, where applicable, contacted known relatives to locate contact information for all interest owners that it seeks to pool. XTO has been able to locate addresses for all the owners it seeks to pool.

9. Because the interest XTO seeks to pool is a non-cost bearing interest, XTO is not requesting to assess a proportionate share of costs, risk charges, or overhead and administrative

costs for drilling and producing the wells.

- 10. XTO has provided the law firm of Holland & Hart LLP with the names and addresses of the record title owners XTO seeks to pool and instructed that they be notified of this hearing.
- 11. **XTO Exhibits C-1 through C-3** were either prepared by me or compiled under my direction and supervision.
- 12. I affirm under penalty of perjury under the laws of the State of New Mexico that the foregoing statements are true and correct. I understand that this self-affirmed statement will be used as written testimony in this case. This statement is made on the date next to my signature below.

EM/XTO Structure Map (true vertical depth subsea)






