## **APPLICANT'S STATEMENT OF THE CASE**

Under these consolidated cases, Matador seeks to reopen the existing orders and pool a record title owner underlying the referenced acreage, all in Township 20 South, Range 29 East, NMPM, Eddy County, New Mexico, as follows:

- In Case 25585, Matador seeks to amend pooling Order No. R-22460 ("Pooling Order"). On December 23, 2022, the Division entered Order No. R-22460 in Case No. 23067, pooling the uncommitted interest owners in the Bone Spring formation (Getty; Bone Spring [27470]) underlying a standard 240-acre, more or less, horizontal well spacing unit comprised of the N/2 S/2 of Section 15 and the N/2 SW/4 of Section 14. Matador is the designated operator under the Pooling Order and the pooled spacing unit is initially dedicated to the drilled and producing **Ted 1514 Federal Com 123H** (API No. 30-015-53697) well.
- In Case 25586, Matador seeks to amend pooling Order No. R-22461 ("Pooling Order").

  On December 23, 2022, the Division entered Order No. R-22461 in Case No. 23068, pooling the uncommitted interest owners in the Bone Spring formation (Getty; Bone Spring [27470]) underlying a standard 240-acre, more or less, horizontal well spacing unit comprised of the S/2 S/2 of Section 15 and the S/2 SW/4 of Section 14. Matador is the designated operator under the Pooling Order and the pooled spacing unit is

initially dedicated to the drilled and producing **Ted 1514 Federal Com 124H (**API No. 30-015-53698) well.

  On December 23, 2022, the Division entered Order No. R-22462 in Case No. 23069, pooling the uncommitted interest owners in the Wolfcamp formation (Burton Flat; Upper Wolfcamp, East (oil) [98315]) underlying a standard 240-acre, more or less, horizontal well spacing unit comprised of the N/2 S/2 of Section 15 and the N/2 SW/4 of Section 14. Matador is the designated operator under the Pooling Order and the pooled spacing unit is initially dedicated to the drilled and producing Ted 1514 Federal Com 203H (API No. 30-015-53674) well.
- In Case 25588, Matador seeks to amend pooling Order No. R-22463 ("Pooling Order").

  On December 23, 2022, the Division entered Order No. R-22463 in Case No. 23070, pooling the uncommitted interest owners in the Wolfcamp formation (Burton Flat; Upper Wolfcamp, East (oil) [98315]) underlying a standard 240-acre, more or less, horizontal well spacing unit comprised of the S/2 S/2 of Section 15 and the S/2 SW/4 of Section 14. Matador is the designated operator under the Pooling Order and the pooled spacing unit is initially dedicated to the drilled and producing **Ted 1514 Federal**Com 204H (API No. 30-015-53678) well.

Applicant pooling a record title owner in the pooled acreage that was not subject to the pooling proceedings giving rise to Order Nos. R-22460-22463. Applicant has sought and been unable to obtain a signature on the federal communitization agreements from this additional record title owner.
