APPLICANT'S STATEMENT OF THE CASE

In **Case No. 25644**, Civitas seeks a one-year extension of time for drilling the well under Order No. R-23636. The unit is comprised of the S/2 of Sections 22 and 23, Township 24 South, Range 26 East, Eddy County, New Mexico (the "Unit") and designated Civitas as operator of the Unit. Order No. R-23636 pooled all uncommitted interests within the Purple Sage; Wolfcamp (Gas) Pool and dedicated the Unit to the proposed initial **Modelo 22-23 Fed Com 211H** well. (API No. 30-015-PENDING).

In **Case No. 25651**, Civitas seeks a one-year extension of time for drilling the well under Order No. R-23612. The unit is comprised of the S/2 of Sections 22 and 23, Township 24 South, Range 26 East, Eddy County, New Mexico (the "Unit") and designated Civitas as operator of the Unit. Order No. R-23612 pooled all uncommitted interests within Willow Lake; Bone Spring West (Code 96415), further limited by a Bone Spring formation depth severance from the stratigraphic equivalent of 8,062', as defined on the Baker Hughes Gamma Ray Log of the Ringer Federal Com 4 well (API No. 30-015-32343) and dedicated the Unit to the proposed initial **Modelo 22-23 Fed Com 131H** well. (API No. 30-015-PENDING).

There is good cause for Applicant's request for an extension to drill. Civitas requests that Orders R-23636 and R-23612 be re-opened and amended to allow Applicant additional time to commence drilling the wells under the Order.

Under Order R-23636, Applicant would be required to commence drilling the initial **Modelo 22-23 Fed Com 211H** well by January 14, 2026. Civitas, therefore, asks for the deadline to commence drilling to be extended for a year, to January 14, 2027.

Under Order R-23612 the initial **Modelo 22-23 Fed Com 131H** well by December 12, 2025. Civitas, therefore, asks for the deadline to commence drilling to be extended for a year, to December 12, 2026.
