APPLICANT'S STATEMENT OF THE CASE

Under these consolidated cases, MRC seeks orders pooling for the referenced acreage as follows:

- In **Case No. 25713**, MRC seeks an order pooling all uncommitted interests in the Bone Spring formation (Salt Lake; Bone Spring [53560] for Section 36 acreage and WC-015 G-06 S203127G; Bone Spring [98332] for Section 1 acreage) underlying a standard 322.53-acre, more or less, horizontal well spacing unit underlying Lots 1, 8, 9, & 16, and the E/2 SE/4 (E/2 E/2 equivalent) of irregular Section 1, Township 21 South, Range 31 East, NMPM, Eddy County, as well as the W/2 SW/4 of Section 36, Township 20 South, Range 32 East, NMPM, Lea County, New Mexico. Applicant seeks to initially dedicate the above-referenced horizontal spacing unit to the proposed **Susan Lancaster Federal Com 131H** well, to be horizontally drilled from a surface location in the NE/4 NW/4 (Unit C) of irregular Section 7, T21S-R32E, with a first take point in the SE/4 SE/4 (Unit P) of irregular Section 1, T21S-R31E, and a last take point in the NW/4 SW/4 (Unit L) of Section 36, T20S-R32E.
- In **Case No. 25714**, MRC seeks an order pooling all uncommitted interests in the Bone Spring formation (Salt Lake; Bone Spring [53560] for Section 36 acreage and WC-015 G-06 S203127G; Bone Spring [98332] for Section 6 acreage) underlying a standard 339.78-acre, more or less, horizontal well spacing unit underlying Lots 4, 5, 12, 13, 17 & 18 (W/2 W/2 equivalent) of irregular Section 6, Township 21 South, Range 32 East, as well as the E/2 SW/4 of Section 36, Township 20 South, Range 32 East, NMPM, Lea County, New Mexico. Applicant seeks to initially

dedicate the above-referenced horizontal spacing unit to the proposed **Susan Lancaster Federal Com 132H** well, to be horizontally drilled from a surface location in the NE/4 NW/4 (Unit C) of irregular Section 7, T21S-R32E, with a first take point in Lot 18 (SW/4 SW/4 equivalent) of irregular Section 6, T21S-R32E, and a last take point in the NE/4 SW/4 (Unit K) of Section 36, T20S-R32E.

- In **Case No. 25715**, MRC seeks an order pooling all uncommitted interests in the Wolfcamp formation (Hat Mesa; Wolfcamp [96438]) underlying a standard 322.53-acre, more or less, horizontal well spacing unit underlying Lots 1, 8, 9, & 16, and the E/2 SE/4 (E/2 E/2 equivalent) of irregular Section 1, Township 21 South, Range 31 East, NMPM, Eddy County, as well as the W/2 SW/4 of Section 36, Township 20 South, Range 32 East, NMPM, Lea County, New Mexico. Applicant seeks to initially dedicate the above-referenced horizontal spacing unit to the proposed **Susan Lancaster Federal Com 201H** well, to be horizontally drilled from a surface location in the NE/4 NW/4 (Unit C) of irregular Section 7, T21S-R32E, with a first take point in the SE/4 SE/4 (Unit P) of irregular Section 1, T21S-R31E, and a last take point in the NW/4 SW/4 (Unit L) of Section 36, T20S-R32E.

The completed interval for the wells will meet the statewide setbacks for oil wells. Applicant has sought and been unable to obtain voluntary agreement for the development of these lands from all interest owners in the subject spacing unit.
