STATEMENT OF THE CASE

Applicant applies for an order pooling all uncommitted interests in the Woodford formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the W/2 W/2 of Sections 28 and 21, Township 26 South, Range 37 East, Lea County, New Mexico (“Unit”). The Unit will be dedicated to the **Pioneer 21 28 Fed Com 951H** well (“Well”), which will be drilled from a surface hole location in the NW/4 NW/4 (Unit D) of Section 21 to a bottom hole location in the SW/4 SW/4 (Unit P) of Section 28.

The completed interval of the Well will be orthodox. Also to be considered will be the cost of drilling and completing the Well, the allocation of the costs, the designation of Applicant as operator of the Unit and the Well, and a 200% charge for the risk involved in drilling and completing the Well.
