APPLICANT'S STATEMENT OF THE CASE

Under these consolidated cases, Mewbourne seeks orders pooling for the referenced acreage, all in Township 18 South, Range 34 East, NMPM, Lea County, New Mexico in the Bone Spring formation (Mescalero Escarpe; Bone Spring [45793]) as follows:

- Under **Case No. 25751**, Mewbourne seeks an order (1) approving an overlapping, 240-acre, more or less, standard horizontal well spacing unit in the Bone Spring formation underlying the W/2 SE/4 of Section 18 and the W/2 E/2 of Section 19, and (2) pooling all uncommitted mineral interests in this acreage, to be initially dedicated to the proposed **Macho Man 18/19 Federal Com 526H** (API No. 30-025-54928) well, to be drilled from a surface hole location in the SW/4 NE/4 (Unit G) of Section 18, to a bottom hole location in SW/4 SE/4 (Unit O) of Section 19. The proposed horizontal well spacing unit will overlap the following existing Bone Spring spacing unit:
 - The 40-acre vertical well spacing unit comprised of the NW/4 SE/4 (Unit J) of Section 18, T18S-R34W, dedicated to Mack Energy Corporation's Cap State #1 (API No. 30-025-40920).
- Under **Case No. 25752**, Mewbourne seeks to pool the uncommitted interest owners in a standard 240-acre, more or less, well spacing unit in the Bone Spring formation underlying the E/2 SE/4 of Section 18 and E/2 E/2 of Section 19, to be initially dedicated to the proposed **Macho Man 18/19 Federal Com 528H** (API No. 30-025-54734) well, to be drilled from a surface hole location in the SW/4 NE/4 (Unit G) of Section 18, to a bottom hole location in SE/4 SE/4 (Unit P) of Section 19.

The completed interval for the wells will comply with statewide setbacks for oil wells. Mewbourne has sought but been unable to obtain voluntary agreement for the development of these lands from all interest owners in the subject spacing units.


