**APPLICANT’S STATEMENT OF THE CASE**

Under these consolidated cases, MRC seeks orders pooling for the referenced acreage as follows:

- In **Case No. 25821**, MRC seeks an order pooling all uncommitted interests in the Bone Spring formation (WC-025 G-06 S213215A; Bone Spring [97921]) underlying a standard 399.73-acre, more or less, horizontal well spacing unit underlying Lots 2, 7, 10, and 15 and W/2 SE/4 (W/2 E/2 equivalent) of irregular Section 3 and the W/2 E/2 of Section 10, Township 21 South, Range 32 East, NMPM, Lea County, New Mexico. Applicant seeks to initially dedicate the above-referenced horizontal spacing unit to the proposed **Electra Special 0310 Fed Com 123H** and **Electra Special 0310 Fed Com 137H** wells, to be horizontally drilled from surface locations in Lot 1 (NE/4 NE/4 equivalent) of irregular Section 3, with first take points in Lot 2 (NW/4 NE/4 equivalent) of irregular Section 3, and last take points in the SW/4 SE/4 (Unit O) of Section 10.
- In **Case No. 25822**, MRC seeks an order (a) approving a standard 399.46-acre, more or less, overlapping horizontal well spacing unit in the Bone Spring formation underlying Lots 1, 8, 9, and 16 and E/2 SE/4 (E/2 E/2 equivalent) of irregular Section 3 and the E/2 E/2 of Section 10, Township 21 South, Range 32 East, NMPM, Lea County, New Mexico; and (b) pooling the uncommitted interest owners in this acreage. Applicant seeks to initially dedicate the above-referenced horizontal spacing unit to the proposed **Electra Special 0310 Fed Com 133H** and **Electra Special 0310 Fed Com 138H** wells, to be horizontally drilled from surface locations in Lot 1 (NE/4 NE/4 equivalent) of irregular Section 3, with first take points in Lot 1 (NE/4 NE/4 equivalent) of irregular Section 3, and last take points in the SE/4 SE/4 (Unit P) of Section 10. This proposed standard horizontal well

spacing unit will overlap the following existing horizontal well spacing unit in the Bone Spring formation:

- 160-acre spacing unit comprised of the E/2 E/2 of Section 10 in the Bone Spring dedicated to the Hat Mesa 10 Federal Com 002H well, operated by Cimarex Energy Co. (“Cimarex”) (API No. 30-025-40365).
- In **Case No. 25823**, MRC seeks an order pooling all uncommitted interests in the Bone Spring formation (WC-025 G-06 S213215A; Bone Spring [97921]) underlying a standard 239.46-acre, more or less, horizontal well spacing unit underlying Lots 1, 8, 9, and 16 and E/2 SE/4 (E/2 E/2 equivalent) of irregular Section 3, Township 21 South, Range 32 East, NMPM, Lea County, New Mexico. Applicant seeks to initially dedicate the above-referenced horizontal spacing unit to the proposed **Electra Special 0310 Fed Com 124H** well, to be horizontally drilled from a surface location in Lot 1 (NE/4 NE/4 equivalent) of irregular Section 3, with a first take point in Lot 1 (NE/4 NE/4 equivalent) of irregular Section 3, and a last take point in the SE/4 SE/4 (Unit P) of irregular Section 3.
- In **Case No. 25824**, MRC seeks an order pooling all uncommitted interests in the Wolfcamp formation (Hat Mesa; Wolfcamp [96438]) underlying a standard 399.73-acre, more or less, horizontal well spacing unit underlying Lots 2, 7, 10, and 15 and W/2 SE/4 (W/2 E/2 equivalent) of irregular Section 3 and the W/2 E/2 of Section 10, Township 21 South, Range 32 East, NMPM, Lea County, New Mexico. Applicant seeks to initially dedicate the above-referenced horizontal spacing unit to the proposed **Electra Special 0310 Fed Com 203H** well, to be horizontally drilled from a surface location in Lot 1 (NE/4 NE/4 equivalent) of irregular Section

3, with a first take point in Lot 2 (NW/4 NE/4 equivalent) of irregular Section 3, and a last take point in the SW/4 SE/4 (Unit O) of Section 10.

- In **Case No. 25825**, MRC seeks an order pooling all uncommitted interests in the Wolfcamp formation (Hat Mesa; Wolfcamp [96438]) underlying a standard 399.73-acre, more or less, horizontal well spacing unit underlying Lots 1, 8, 9, and 16 and E/2 SE/4 (E/2 E/2 equivalent) of irregular Section 3 and the E/2 E/2 of Section 10, Township 21 South, Range 32 East, NMPM, Lea County, New Mexico. Applicant seeks to initially dedicate the above-referenced horizontal spacing unit to the proposed **Electra Special 0310 Fed Com 204H** well, to be horizontally drilled from a surface location in Lot 1 (NE/4 NE/4 equivalent) of irregular Section 3, with a first take point in Lot 1 (NE/4 NE/4 equivalent) of irregular Section 3, and a last take point in the SE/4 SE/4 (Unit P) of Section 10.

The completed interval for the wells will meet the statewide setbacks for oil wells. Applicant will separately seek administrative approval for the proposed nonstandard location for the Electra Special 0310 Fed Com 133H well. Applicant has sought and been unable to obtain voluntary agreement for the development of these lands from all interest owners in the subject spacing unit.
