**APPLICANT'S STATEMENT OF THE CASE**

Under these consolidated cases, MRC seeks orders pooling for the referenced acreage as follows:

- In Case No. 25976, MRC seeks an order pooling all uncommitted interests in the Wolfcamp formation (Hat Mesa; Wolfcamp [96438]) underlying a standard 320-acre, more or less, horizontal well spacing unit underlying the E/2 W/2 of Sections

28 and 33, Township 20 South, Range 33 East, NMPM, Lea County, New Mexico. Applicant seeks to initially dedicate the above-referenced horizontal spacing unit to the proposed **Gavilon Fed Com 242H** well, to be horizontally drilled from a surface location in the SW/4 SW/4 (Unit M) of Section 33, with a first take point in the SE/4 SW/4 (Unit N) of Section 33, and a last take point in the NE/4 NW/4 (Unit C) of Section 28, T20S-R33E.

- In **Case No. 25978**, MRC seeks an order pooling all uncommitted interests in the Wolfcamp formation (Hat Mesa; Wolfcamp [96438]) underlying a standard 320-acre, more or less, horizontal well spacing unit underlying the E/2 E/2 of Sections 28 and 33, Township 20 South, Range 33 East, NMPM, Lea County, New Mexico. Applicant seeks to initially dedicate the above-referenced horizontal spacing unit to the proposed **Gavilon Fed Com 244H** well, to be horizontally drilled from a surface location in the SW/4 SE/4 (Unit O) of Section 33, with a first take point in the SE/4 SE/4 (Unit P) of Section 33, and a last take point in the NE/4 NE/4 (Unit A) of Section 28, T20S-R33E.

The completed interval for the wells will meet the statewide setbacks for oil wells. Applicant has sought and been unable to obtain voluntary agreement for the development of these lands from all interest owners in the subject spacing unit.
