APPLICANT’S STATEMENT OF THE CASES

Under these consolidated cases, MRC seeks orders pooling all uncommitted interests in the following proposed horizontal well spacing units underlying acreage within Township 21 South, Range 33 East, and Township 22 South, Range 33 East, NMPM, Lea County, New Mexico:

- Under **Case No. 25998**, MRC seeks an order (1) approving a 560.05-acre, more or less, overlapping horizontal well spacing unit in the Bone Spring formation (WC-025 G-07 S213330F; BONE SPRING [Pool Code 97927] and LEGG; BONE SPRING [Pool Code 37870]) underlying the W/2 of Section 29, E/2 W/2 of Section 32, T21S-R33E, and Lot 3 and SE/4 NW/4 (E/2 NW/4 equivalent) of irregular Section 5, T22S-R33E, and (2) pooling all uncommitted interests in this acreage. MRC seeks to dedicate this overlapping horizontal spacing unit to the proposed **Toddy Glosser State Com 110H** j-turn well, to be drilled from a surface hole location in the N/2 of irregular Section 5, T22S-R33E, to a first take point in the SE/4 NW/4 (Unit F) of irregular Section 5, T22S-R33E, and a last take point in the SW/4 NW/4 (Unit E) of Section 29, T21S-R33E. This proposed horizontal well spacing unit will overlap the following existing spacing units in the Bone Spring formation:
 - An existing 160-acre spacing unit in the Bone Spring formation underlying the E/2 W/2 of Section 29, T21S-R33E, currently dedicated to the Fruit Loop 29 State 501H (API No. 30-025-41518), operated by EOG Resources Inc; and
 - An existing 160-acre spacing unit in the Bone Spring formation underlying the W/2 W/2 of Section 29, T21S-R33E, currently dedicated to the Fruit Loop 29 State 503H (API No. 30-025-44501) and Fruit Loop 29 State 602H (API No. 30-025-44500), operated by EOG Resources Inc.
- Under **Case No. 25999**, MRC seeks an order pooling the uncommitted interest owners in a 560.05-acre, more or less, horizontal well spacing unit in the Wolfcamp formation (WC-025 G-10 S213328O; WOLFCAMP [Pool Code 98033]) underlying the W/2 of Section 29, E/2 W/2 of Section 32, T21S-R33E, and Lot 3 and SE/4 NW/4 (E/2 NW/4 equivalent) of irregular Section 5, T22S-R33E. MRC seeks to dedicate this overlapping horizontal spacing unit to the proposed **Toddy Glosser State Com 200H** j-turn well, to be drilled from a surface hole location in the N/2 of irregular Section 5, T22S-R33E, to a first take

point in the SE/4 NW/4 (Unit F) of irregular Section 5, T22S-R33E, and a last take point in the SW/4 NW/4 (Unit E) of Section 29, T21S-R33E.

The completed interval for the wells will comply with statewide setbacks for oil. MRC has sought and been unable to obtain voluntary agreement for the development of these lands from all interest owners in the subject acreage.
