MOTION TO AMEND PRE-HEARING ORDER

Coterra Energy Operating Co. (“Coterra”) respectfully moves to amend the Pre-Hearing Order setting the above captioned Permian Resources Operating LLC (“Permian Resources”) cases for a contested hearing on April 28, 2026, to add Coterra’s competing cases to the Pre-Hearing Order. In support, Coterra states:

1. Permian Resources Case Nos. 25812 and 25814 are currently set for a contested hearing on April 28, 2026 pursuant to a pre-hearing order issued by the Division on January 28, 2026.
2. Coterra filed applications that compete with Permian Resources’ cases, which were cases were assigned Case Nos. 26030 and 26031.

3. The Pre-Hearing Order setting Case Nos. 25812 and 25814 for a contested hearing on April 28, 2026 should thus be amended to add Coterra Case Nos. 26030 and 26031, to also be heard on August 28, 2026.

4. Counsel for Permian Resources was contacted and does not object to the motion. Counsel for COG Operating LLC was also contacted and does not object to the motion.

WHEREFORE, Coterra respectfully requests that the Division amend the Pre-Hearing Order as outlined herein. A proposed word version of an order granting this motion will be sent to the Division via email.
